A bill to amend section 7 of Act No. 217 of the Public Acts of 1956, entitled as amended

"Electrical administrative act,"

being section 338.887 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 7 of Act No. 217 of the Public Acts of
- 2 1956, being section 338.887 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 7. No A person, firm, or corporation shall NOT
- 5 engage in the business of electrical contracting unless -such-
- 6 THE person, firm, or corporation -shall have HAS received from
- 7 the board or from the appropriate municipality an electrical
- 8 contractor's license. -Nor shall any A person, other than an
- 9 electrical journeyman, -except- OR a person -duly licensed and
- 10 employed by and working under the direction of a holder of an

- 1 electrical contractor's license, SHALL NOT in any manner
- 2 undertake to execute any electrical wiring. -; except, no-
- 3 HOWEVER, A license shall NOT be required by the board for -the
- 4 home owner A HOMEOWNER to perform the work indicated in subsec-
- 5 tion (g) -nor shall AND a license or permit SHALL NOT be
- 6 required to execute the work covered by subsections (a), (b),
- 7 (c), (d), (e), (f), -and- (h), AND (I) to execute the following
- 8 classes of work:
- 9 (a) Minor repair work, as defined in section 1.
- (b) The installation, alteration, repairing, rebuilding, or
- 11 remodeling of elevators, dumbwaiters, escalators, or -man-lifts
- 12 where being done under a permit issued by an elevator inspection
- 13 agency of the state -of-Michigan or political subdivision
- 14 thereof OF THE STATE.
- (c) The installation, alteration, or repair of electrical
- 16 equipment and its associated wiring, installed on the premises of
- 17 consumers or subscribers by or for electrical energy supply or
- 18 communication agencies for use by such agencies in the genera-
- 19 tion, transmission, distribution, or metering of electrical
- 20 energy, or for the operation of signals or transmission of
- 21 intelligence.
- 22 (d) The installation, alteration, or repair of electric
- 23 wiring for the generation and primary distribution of electric
- 24 current, or the secondary distribution system up to and including
- 25 the meters, where such work is an integral part of the system
- 26 owned and operated by an electric light and power utility in
- 27 rendering its -duly- authorized service.

- (e) Any work involved in the manufacture of electric
 equipment, and the testing and repairing of such manufactured
- 3 equipment.
- 4 (f) The installation, alteration, or repair of equipment and
- 5 its associated wiring for the generation or distribution of elec-
- 6 tric energy for the operation of signals or transmission of
- 7 intelligence where such work is in connection with a communica-
- 8 tion system owned or operated by a telephone or telegraph com-
- 9 pany, in rendering its -duly authorized service as a telephone
- 10 or telegraph company.
- (g) Any installation, alteration, or repair of electrical
- 12 equipment in a single family home and accompanying outbuildings
- 13 owned and occupied or to be occupied by the person performing the
- 14 installation, alteration, or repair of electrical equipment.
- (h) Any work involved in the use, maintenance, operation,
- 16 dismantling, or reassembling of motion picture and theatrical
- 17 equipment used in any building with approved facilities for
- 18 entertainment or educational use and which has the necessary per-
- 19 manent wiring, floor, and wall receptacle outlets designed for
- 20 the proper and safe use of such theatrical equipment, but not
- 21 including any permanent wiring.
- 22 (I) ELECTRICAL WIRING ASSOCIATED WITH THE INSTALLATION,
- 23 REMOVAL, ALTERATION, OR REPAIR OF A WATER WELL PUMP BY A REGIS-
- 24 TERED PUMP INSTALLER UNDER PART 127 OF THE PUBLIC HEALTH CODE,
- 25 ACT NO. 368 OF THE PUBLIC ACTS OF 1978, BEING SECTIONS 333.12701
- 26 TO 333.12771 OF THE MICHIGAN COMPILED LAWS.

Section 2. This amendatory act shall not take effect unless 2 House Bill No. 4656 of the 85th Legislature is enacted into law.
