THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 169 and 241 of Act No. 288 of the

- 4 Sec. 169. When THE PLAT IS approved by a majority of the
- 5 county plat board, the clerk of the board shall -secure a warrant
- 6 from the county treasurer for 1/2 the filing and recording fee
- 7 required by section 241 and forward it with all copies of the
- 8 plat to the state. -treasurer.-

- 1 Sec. 241. (!) When the final plat is submitted to the clerk
 2 of the governing body of the municipality, the proprietor shall
- 3 deposit with the plat -a BOTH OF THE FOLLOWING:
- 4 (A) A fee of \$20.00, which shall be known as the filing and
- 5 recording fee and shall be in addition to any fee the municipal-
