- 6 Compiled Laws, shall be \$220.00.
- 7 (G) (F) The fee for a lifetime trout and salmon license,
- 8 equivalent to the annual trout and salmon stamp issued pursuant
- 9 to section 315 of the hunting and fishing license act, Act No. 86
- 10 of the Public Acts of 1980, being section 316.315 of the Michigan
- 11 Compiled Laws, shall be \$220.00.
- (2) A lifetime license issued pursuant to this section shall
- 13 allow the holder of that license, throughout his or her lifetime,
- 14 the same privileges, responsibilities, and duties as would the
- 15 equivalent annual license or stamp issued pursuant to the hunting
- 16 and fishing license act, Act No. 86 of the Public Acts of 1980,
- 17 being sections 316.101 to 316.902 of the Michigan Compiled Laws.
- 18 (3) A lifetime license issued to a person who is a resident
- 19 of this state at the time the license is purchased shall continue
- 20 to be valid even if the holder of that license becomes a
- 21 nonresident.
