

HOUSE BILL No. 5004

July 27, 1989, Introduced by Reps. Gubow, Stabenow, Leland and Gire and referred to the Committee on Public Health.

A bill to amend section 16263 of Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

as amended by Act No. 473 of the Public Acts of 1988, being section 333.16263 of the Michigan Compiled Laws; to add part 185; to repeal certain parts of the act on a specific date; and to repeal certain acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 16263 of Act No. 368 of the Public Acts
2 of 1978, as amended by Act No. 473 of the Public Acts of 1988,
3 being section 333.16263 of the Michigan Compiled Laws, is amended
4 and part 185 is added to read as follows:

5 Sec. 16263. (1) Except as provided in subsection (2), the
6 following words, titles, or letters or a combination thereof,
7 with or without qualifying words or phrases, are restricted in

1 use only to those persons authorized under this article to USE
2 the terms and in a way prescribed in this article:

3 (a) "Chiropractic", "doctor of chiropractic",
4 "chiropractor", "d.c.", and "chiropractic physician".

5 (b) "Dentist", "doctor of dental surgery", "oral and maxil-
6 lofacial surgeon", "orthodontist", ~~"prosthodontist"~~
7 "PROSTHODONTIST", "periodontist", "endodontist", "pediatric
8 dentist", "dental hygienist", "registered dental hygienist",
9 "dental assistant", "registered dental assistant", "R.D.A.",
10 "d.d.s.", "d.m.d.", and "r.d.h.".

11 (c) "Doctor of medicine" and "m.d.".

12 (d) "Physician's assistant" and "p.a.".

13 (e) "Registered professional nurse", "registered nurse",
14 "r.n.", "licensed practical nurse", "l.p.n.", "nurse midwife",
15 "nurse anesthetist", "nurse practitioner", "trained attendant",
16 and "t.a.".

17 (f) "Doctor of optometry", "optometrist", and "o.d.".

18 (g) "Osteopath", "osteopathy", "osteopathic practitioner",
19 "doctor of osteopathy", "diplomate in osteopathy", and "d.o.".

20 (h) "Pharmacy", "pharmacist", "apothecary", "drugstore",
21 "druggist", "medicine store", "prescriptions", and "r.ph.".

22 (i) "Physical therapy", "physical therapist",
23 "physiotherapist", "registered physical therapist", "licensed
24 physical therapist", "physical therapy technician", "p.t.",
25 "r.p.t.", "l.p.t.", and "p.t.t.".

1 (j) "Chiropodist", "chiropody", "chiropodical", "podiatry",
 2 "podiatrist", "podiatric", "doctor of podiatric medicine", "foot
 3 specialist", "podiatric physician and surgeon", and "d.p.m.".

4 (k) "Consulting psychologist", "psychologist",
 5 "psychological assistant", and "psychological examiner",
 6 "licensed psychologist", and "limited licensed psychologist".

7 (l) "Licensed professional counselor", "licensed counselor",
 8 "professional counselor", and "l.p.c.".

9 (m) "Sanitarian", "registered sanitarian", and "r.s.".

10 (n) "Veterinary", "veterinarian", "veterinary doctor",
 11 "veterinary surgeon", "doctor of veterinary medicine", "v.m.d.",
 12 "d.v.m.", and after July 1, 1979, "animal technician", or "animal
 13 technologist".

14 (o) "Occupational therapist", "occupational therapist
 15 registered", "certified occupational therapist", "o.t.",
 16 "o.t.r.", "c.o.t.", "certified occupational therapy assistant",
 17 "occupational therapy assistant", or "c.o.t.a.".

18 (P) "LICENSED MASTER SOCIAL WORKER", "LICENSED BACHELOR
 19 SOCIAL WORKER", "REGISTERED SOCIAL WORK ASSOCIATE", "L.M.S.W.",
 20 "L.B.S.W.", AND "R.S.W.A.".

21 (2) Notwithstanding section 16261, a person who was spe-
 22 cially trained at an institution of higher education in this
 23 state to assist a physician in the field of orthopedics and upon
 24 completion of training, received a 2-year associate of science
 25 degree as an orthopedic physician's assistant before January 1,
 26 1977, may use the title "orthopedic physician's assistant"
 27 whether or not the person is licensed under this article.

PART 185. SOCIAL WORK

SEC. 18501. AS USED IN THIS PART:

(A) "LICENSED BACHELOR SOCIAL WORKER" MEANS AN INDIVIDUAL LICENSED UNDER THIS ARTICLE TO ENGAGE IN THE PRACTICE OF SOCIAL WORK AT THE BACHELOR'S LEVEL.

(B) "LICENSED MASTER SOCIAL WORKER" MEANS AN INDIVIDUAL LICENSED UNDER THIS ARTICLE TO ENGAGE IN THE PRACTICE OF SOCIAL WORK AT THE MASTER'S LEVEL.

(C) "PRACTICE OF MEDICINE" MEANS THAT TERM AS DEFINED IN SECTION 17001.

(D) "PRACTICE OF OSTEOPATHIC MEDICINE AND SURGERY" MEANS THAT TERM AS DEFINED IN SECTION 17501.

(E) "PRACTICE OF SOCIAL WORK AT THE BACHELOR'S LEVEL" MEANS ALL OF THE FOLLOWING, BUT SHALL NOT INCLUDE THE PRACTICE OF MEDICINE OR THE PRACTICE OF OSTEOPATHIC MEDICINE AND SURGERY INCLUDING, BUT NOT LIMITED TO, THE PRESCRIBING OF DRUGS OR THE ADMINISTRATION OF ELECTROCONVULSIVE THERAPY:

(i) THE KNOWLEDGE OF HUMAN DEVELOPMENT AND BEHAVIOR; SOCIAL, ECONOMIC, AND CULTURAL INSTITUTIONS; AND COUNSELING TECHNIQUES AND THE INTERACTION OF THAT KNOWLEDGE WITH SOCIAL WORK VALUES, PRINCIPLES, AND TECHNIQUES IN PROVIDING PEOPLE WITH HUMAN SERVICES.

(ii) SOCIAL CASEWORK, INCLUDING, BUT NOT LIMITED TO, SOCIAL ASSESSMENTS, PLANNING, AND INTERVENTION WITH INDIVIDUALS, FAMILIES, COUPLES, OR GROUPS.

(iii) HELPING COMMUNITIES, ORGANIZATIONS, OR GROUPS IMPROVE THEIR SOCIAL OR HEALTH SERVICES.

1 (F) "PRACTICE OF SOCIAL WORK AT THE MASTER'S LEVEL" MEANS
2 ALL OF THE FOLLOWING, BUT SHALL NOT INCLUDE THE PRACTICE OF MEDI-
3 CINE OR THE PRACTICE OF OSTEOPATHIC MEDICINE AND SURGERY INCLUD-
4 ING, BUT NOT LIMITED TO, THE PRESCRIBING OF DRUGS OR THE ADMINIS-
5 TRATION OF ELECTROCONVULSIVE THERAPY:

6 (i) THE KNOWLEDGE OF HUMAN DEVELOPMENT AND BEHAVIOR; SOCIAL,
7 ECONOMIC, AND CULTURAL INSTITUTIONS; AND COUNSELING TECHNIQUES
8 AND THE INTERACTION OF THAT KNOWLEDGE WITH SOCIAL WORK VALUES,
9 PRINCIPLES, AND TECHNIQUES IN PROVIDING PEOPLE WITH PROFESSIONAL
10 HUMAN SERVICES.

11 (ii) PSYCHOTHERAPY APPLIED WITHIN THE SCOPE OF SOCIAL WORK
12 VALUES, PRINCIPLES, AND TECHNIQUES; PSYCHOSOCIAL DIAGNOSIS AND
13 TREATMENT OF EMOTIONAL AND BEHAVIORAL FUNCTIONING; AND SOCIAL
14 ASSESSMENTS, PLANNING, AND INTERVENTION WITH INDIVIDUALS, FAMI-
15 LIES, COUPLES, OR GROUPS.

16 (iii) HELPING COMMUNITIES, ORGANIZATIONS, OR GROUPS IMPROVE
17 THEIR SOCIAL OR HEALTH SERVICES.

18 (iv) PROVIDING SOCIAL CASEWORK.

19 SEC. 18505. BEGINNING 1 YEAR AFTER THE EFFECTIVE DATE OF
20 THIS PART, AN INDIVIDUAL SHALL NOT ENGAGE IN THE PRACTICE OF
21 SOCIAL WORK AT THE BACHELOR'S OR MASTER'S LEVEL OR WORK AS A REG-
22 ISTERED SOCIAL WORK ASSOCIATE UNLESS LICENSED, REGISTERED, OR
23 OTHERWISE AUTHORIZED BY THIS ARTICLE.

24 SEC. 18511. AN INDIVIDUAL WHO IS ISSUED A LIMITED LICENSE
25 UNDER SECTION 18525 AND IS ENGAGED IN THE 2-YEAR POST-DEGREE
26 EXPERIENCE IN THE PRACTICE OF SOCIAL WORK AT THE BACHELOR'S OR
27 MASTER'S LEVEL SHALL PRACTICE UNDER THE SUPERVISION OF A LICENSED

1 MASTER SOCIAL WORKER, AND CONFINE HIS OR HER PRACTICE TO AN
2 AGENCY, HOSPITAL, CLINIC, OR OTHER ARRANGEMENT APPROVED BY THE
3 BOARD. A LIMITED LICENSE IS VALID FOR NOT MORE THAN 3 YEARS
4 AFTER THE DATE OF ISSUANCE. IF PERMITTED BY THE BOARD, A LIMITED
5 LICENSE MAY BE RENEWED 1 TIME FOR A PERIOD OF NOT MORE THAN 2
6 YEARS AFTER THE DATE OF ISSUANCE.

7 SEC. 18515. (1) THIS PART DOES NOT PROHIBIT AN INDIVIDUAL
8 WHO IS ENGAGED IN A COURSE OF STUDY LEADING TO A DEGREE IN SOCIAL
9 WORK FROM PARTICIPATING IN AN INTERNSHIP SUPERVISED BY A LICENSED
10 MASTER SOCIAL WORKER.

11 (2) THIS PART DOES NOT PROHIBIT AN INDIVIDUAL WHO IS NOT
12 LICENSED OR OTHERWISE AUTHORIZED UNDER THIS ARTICLE TO ENGAGE IN
13 THE PRACTICE OF SOCIAL WORK AT THE BACHELOR'S OR MASTER'S LEVEL
14 OR REGISTERED AS A SOCIAL WORK ASSOCIATE FROM WORKING FOR, OR
15 DONATING HIS OR HER SERVICES TO, A COMMUNITY ORGANIZATION OR NON-
16 PROFIT CHARITABLE ORGANIZATION, SO LONG AS THE INDIVIDUAL DOES
17 NOT HOLD HIMSELF OR HERSELF OUT TO THE PUBLIC AS BEING A SOCIAL
18 WORKER LICENSED, REGISTERED, OR OTHERWISE AUTHORIZED UNDER THIS
19 ARTICLE.

20 (3) THIS PART DOES NOT PROHIBIT A PROFESSIONAL COUNSELOR,
21 PROFESSIONAL EDUCATOR, OR MEMBER OF THE CLERGY FROM PRACTICING
22 HIS OR HER PROFESSION OR CALLING CONSISTENT WITH HIS OR HER
23 TRAINING AND THE CODE OF ETHICS FOR THAT PROFESSION OR CALLING,
24 SO LONG AS THE INDIVIDUAL DOES NOT HOLD HIMSELF OR HERSELF OUT TO
25 THE PUBLIC AS BEING A SOCIAL WORKER LICENSED, REGISTERED, OR OTH-
26 ERWISE AUTHORIZED UNDER THIS ARTICLE.

1 (4) THIS PART DOES NOT PROHIBIT A CERTIFIED, LICENSED, OR
2 OTHERWISE STATUTORILY RECOGNIZED MEMBER OF ANY PROFESSION FROM
3 PRACTICING HIS OR HER PROFESSION AS AUTHORIZED BY LAW, SO LONG AS
4 THE INDIVIDUAL DOES NOT HOLD HIMSELF OR HERSELF OUT TO THE PUBLIC
5 AS BEING A SOCIAL WORKER LICENSED, REGISTERED, OR OTHERWISE
6 AUTHORIZED UNDER THIS ARTICLE.

7 SEC. 18521. THE MICHIGAN BOARD OF SOCIAL WORK IS CREATED
8 WITHIN THE DEPARTMENT. THE BOARD SHALL CONSIST OF THE FOLLOWING
9 6 VOTING MEMBERS WHO MEET THE REQUIREMENTS OF PART 161:

10 (A) FIVE INDIVIDUALS ENGAGED PRIMARILY IN THE PRACTICE OF
11 SOCIAL WORK, 3 OF WHOM ARE DIRECT PROVIDERS OF SERVICE, 1 OF WHOM
12 IS ENGAGED IN THE ADMINISTRATION OF SOCIAL WORK SERVICES, AND 1
13 OF WHOM IS ENGAGED PRIMARILY IN TEACHING, TRAINING, OR RESEARCH
14 IN SOCIAL WORK. AT LEAST 1 OF THE MEMBERS DESCRIBED IN THIS SUB-
15 DIVISION SHALL BE A LICENSED BACHELOR SOCIAL WORKER, AND ALL OF
16 THE MEMBERS DESCRIBED IN THIS SUBDIVISION SHALL MEET THE REQUIRE-
17 MENTS OF SECTION 16135(2).

18 (B) ONE PUBLIC MEMBER.

19 SEC. 18525. (1) EXCEPT AS OTHERWISE PROVIDED IN SECTION
20 18533, THE BOARD, BY RULE, SHALL REQUIRE THAT AN INDIVIDUAL
21 GRANTED A LICENSE UNDER THIS PART MEET THE FOLLOWING
22 REQUIREMENTS:

23 (A) A LICENSED BACHELOR SOCIAL WORKER SHALL HAVE BEEN
24 AWARDED A BACHELOR'S DEGREE IN SOCIAL WORK FROM A COLLEGE OR UNI-
25 VERSITY ACCREDITED BY THE BOARD, AND SHALL HAVE COMPLETED AT
26 LEAST 2 YEARS OF FULL-TIME POST-BACHELOR'S DEGREE EXPERIENCE, OR
27 THE EQUIVALENT IN PART-TIME HOURS, IN THE PRACTICE OF SOCIAL WORK

1 AT THE BACHELOR'S LEVEL UNDER THE SUPERVISION OF A LICENSED
2 MASTER SOCIAL WORKER, EXCEPT THAT DURING A PERIOD ENDING 2 YEARS
3 AFTER THE EFFECTIVE DATE OF THIS PART, THE REQUIRED EXPERIENCE IN
4 THE PRACTICE OF SOCIAL WORK AT THE BACHELOR'S LEVEL MAY BE PER-
5 FORMED UNDER THE SUPERVISION OF A PERSON WHO HAS BEEN AWARDED A
6 MASTER'S OR DOCTORAL DEGREE IN SOCIAL WORK FROM A COLLEGE OR UNI-
7 VERSITY SCHOOL OF SOCIAL WORK. A LICENSED BACHELOR SOCIAL WORKER
8 SHALL CONFINE HIS OR HER PRACTICE TO AN AGENCY, HOSPITAL, CLINIC,
9 OR OTHER ARRANGEMENT APPROVED BY THE BOARD.

10 (B) A LICENSED MASTER SOCIAL WORKER SHALL HAVE BEEN AWARDED
11 A MASTER'S OR DOCTORAL DEGREE IN SOCIAL WORK FROM A COLLEGE OR
12 UNIVERSITY SCHOOL OF SOCIAL WORK ACCREDITED BY THE BOARD, AND
13 SHALL HAVE COMPLETED AT LEAST 2 YEARS OF FULL-TIME POST-MASTER'S
14 OR POSTDOCTORAL DEGREE EXPERIENCE, OR THE EQUIVALENT IN PART-TIME
15 HOURS, IN THE PRACTICE OF SOCIAL WORK AT THE MASTER'S LEVEL UNDER
16 THE SUPERVISION OF A LICENSED MASTER SOCIAL WORKER, EXCEPT THAT
17 DURING A PERIOD ENDING 2 YEARS AFTER THE EFFECTIVE DATE OF THIS
18 PART, THE REQUIRED EXPERIENCE IN THE PRACTICE OF SOCIAL WORK AT
19 THE MASTER'S LEVEL MAY BE PERFORMED UNDER THE SUPERVISION OF A
20 PERSON WHO HAS BEEN AWARDED A MASTER'S OR DOCTORAL DEGREE IN
21 SOCIAL WORK FROM A COLLEGE OR UNIVERSITY SCHOOL OF SOCIAL WORK.

22 (2) THE BOARD SHALL GRANT A LIMITED LICENSE TO AN INDIVIDUAL
23 WHO HAS COMPLETED ALL THE EDUCATIONAL REQUIREMENTS FOR LICENSURE
24 AS A BACHELOR SOCIAL WORKER OR A MASTER SOCIAL WORKER.

25 SEC. 18529. (1) THE BOARD SHALL ISSUE A CERTIFICATE OF REG-
26 ISTRATION AS A SOCIAL WORK ASSOCIATE TO AN INDIVIDUAL WHO HAS
27 BEEN GRANTED AN ASSOCIATE'S DEGREE IN SOCIAL WORK, INCLUDING

1 SUPERVISED INSTRUCTIONAL FIELD WORK, FROM A COLLEGE OR UNIVERSITY
2 ACCREDITED BY THE BOARD. AN INDIVIDUAL ISSUED A CERTIFICATE OF
3 REGISTRATION UNDER THIS SECTION SHALL CONFINE HIS OR HER PRACTICE
4 TO SOCIAL SERVICES ACTIVITIES PERFORMED IN A HOSPITAL, AGENCY,
5 CLINIC, OR OTHER ARRANGEMENT APPROVED BY THE BOARD WHILE UNDER
6 THE SUPERVISION OF A LICENSED MASTER SOCIAL WORKER.

7 (2) THIS SECTION IS REPEALED EFFECTIVE JANUARY 1, 1995.

8 SEC. 18533. (1) THE BOARD SHALL GRANT A FULL LICENSE AS A
9 LICENSED BACHELOR SOCIAL WORKER TO AN INDIVIDUAL WHO HOLDS A CER-
10 TIFICATE OF REGISTRATION AS A SOCIAL WORKER ISSUED BEFORE THE
11 EFFECTIVE DATE OF THIS PART PURSUANT TO FORMER ARTICLE 16 OF ACT
12 NO. 299 OF THE PUBLIC ACTS OF 1980, AND APPLIES TO THE BOARD FOR
13 LICENSURE WITHIN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS PART.

14 (2) THE BOARD SHALL GRANT A FULL LICENSE AS A LICENSED
15 MASTER SOCIAL WORKER TO AN INDIVIDUAL WHO HOLDS A CERTIFICATE OF
16 REGISTRATION AS A CERTIFIED SOCIAL WORKER ISSUED BEFORE THE
17 EFFECTIVE DATE OF THIS PART PURSUANT TO FORMER ARTICLE 16 OF ACT
18 NO. 299 OF THE PUBLIC ACTS OF 1980, AND APPLIES TO THE BOARD FOR
19 LICENSURE WITHIN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS PART.

20 (3) THE BOARD SHALL ISSUE A CERTIFICATE OF REGISTRATION AS A
21 SOCIAL WORK ASSOCIATE TO AN INDIVIDUAL WHO HOLDS A CERTIFICATE OF
22 REGISTRATION AS A SOCIAL WORK TECHNICIAN ISSUED BEFORE THE EFFEC-
23 TIVE DATE OF THIS PART PURSUANT TO FORMER ARTICLE 16 OF ACT
24 NO. 299 OF THE PUBLIC ACTS OF 1980, AND APPLIES TO THE BOARD FOR
25 REGISTRATION WITHIN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS
26 PART.

1 (4) AN INDIVIDUAL LICENSED OR REGISTERED UNDER THIS SECTION
2 SHALL MEET THE REQUIREMENTS OF SECTION 18537 WHEN RENEWING HIS OR
3 HER LICENSE OR REGISTRATION. THE BOARD SHALL ENSURE THAT THE
4 INDIVIDUAL CONTINUES TO MEET THE APPLICABLE EDUCATIONAL AND PRAC-
5 TICE STANDARDS.

6 SEC. 18537. IN ADDITION TO THE REQUIREMENTS OF PART 161,
7 THE BOARD SHALL REQUIRE A LICENSEE OR REGISTRANT SEEKING RENEWAL
8 TO FURNISH EVIDENCE THAT DURING THE 3 YEARS IMMEDIATELY PRECEDING
9 APPLICATION FOR RENEWAL, THE LICENSEE OR REGISTRANT ATTENDED
10 TRAINING COURSES OR PROGRAMS RELATED TO THE PRACTICE OF SOCIAL
11 WORK AND DESIGNED TO FURTHER EDUCATE LICENSEES AND REGISTRANTS.
12 THE TOTAL NUMBER OF COURSE OR PROGRAM HOURS REQUIRED BY THIS SEC-
13 TION SHALL BE ESTABLISHED BY THE BOARD BY RULE, BUT SHALL NOT BE
14 LESS THAN 60 CLOCK HOURS.

15 SEC. 18541. (1) THE BOARD SHALL ESTABLISH PUBLIC POLICY FOR
16 THE REGULATION OF THE SOCIAL WORK PROFESSION AND SHALL ADOPT A
17 CODE OF SOCIAL WORK ETHICS. THE CODE OF SOCIAL WORK ETHICS SHALL
18 INCLUDE, BUT NOT BE LIMITED TO, A REQUIREMENT THAT A LICENSEE
19 SHALL NOT PRACTICE IN AN AREA FOR WHICH HE OR SHE IS NOT
20 TRAINED. THE BOARD SHALL PROVIDE COPIES OF THE CODE OF ETHICS TO
21 ALL INDIVIDUALS LICENSED OR REGISTERED UNDER THIS PART.

22 (2) THE BOARD SHALL PUBLISH AND UPDATE ANNUALLY A LIST OF
23 PERSONS LICENSED OR REGISTERED UNDER THIS PART, AND SHALL MAKE
24 COPIES OF THE LIST AVAILABLE ON REQUEST.

25 SEC. 18545. COMMUNICATIONS BETWEEN A CLIENT AND A LICENSEE
26 OR REGISTRANT UNDER THIS PART IN THE COURSE OF PROFESSIONAL
27 PRACTICE ARE CONFIDENTIAL AND SHALL BE DISCLOSED ONLY PURSUANT TO

1 THE CONSENT OF THE CLIENT OR, IF THE CLIENT IS A MINOR, THE
2 CONSENT OF THE PARENT OR LEGAL GUARDIAN OF THE MINOR OR AS OTHER-
3 WISE PROVIDED BY LAW.

4 SEC. 18547. (1) A LICENSEE OR REGISTRANT SHALL FURNISH A
5 PROFESSIONAL DISCLOSURE STATEMENT TO A PROSPECTIVE CLIENT BEFORE
6 ENGAGING IN SOCIAL WORK SERVICES.

7 (2) A PROFESSIONAL DISCLOSURE STATEMENT REQUIRED UNDER THIS
8 SECTION SHALL CONTAIN ALL OF THE FOLLOWING:

9 (A) THE LICENSEE'S OR REGISTRANT'S NAME, BUSINESS ADDRESS,
10 AND THE TELEPHONE NUMBER.

11 (B) A DESCRIPTION OF THE LICENSEE'S OR REGISTRANT'S
12 PRACTICE.

13 (C) A DESCRIPTION OF THE EDUCATION AND EXPERIENCE OF THE
14 LICENSEE OR REGISTRANT.

15 (D) THE LICENSEE'S OR REGISTRANT'S FEE SCHEDULE.

16 (E) THE NAME, ADDRESS, AND TELEPHONE NUMBER OF THE
17 DEPARTMENT.

18 (3) THE DISCLOSURE STATEMENT TO BE USED BY THE APPLICANT
19 SHALL ACCOMPANY THE ORIGINAL APPLICATION FOR LICENSURE OR
20 REGISTRATION. IF THE LICENSEE OR REGISTRANT MAKES A CHANGE IN
21 THE DISCLOSURE STATEMENT, THE LICENSEE OR REGISTRANT SHALL FILE
22 THE CHANGE WITH THE DEPARTMENT WITHIN 30 DAYS AFTER THE CHANGE IS
23 MADE.

24 Section 2. Article 16 of Act No. 299 of the Public Acts of
25 1980, being sections 339.1601 to 339.1610 of the Michigan
