

HOUSE BILL No. 5008

A bill to amend sections 1 and 2 of Act No. 191 of the Public Acts of 1982, entitled

"An act to provide for the declaration of a state of energy emergency; to provide for procedures to be followed after a declaration of a state of energy emergency; to create an energy advisory committee and prescribe its powers and duties; to prescribe the powers and duties of the governor; to prescribe penalties; and to repeal certain acts and parts of acts,"

being sections 10.81 and 10.82 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 1 and 2 of Act No. 191 of the Public
2 Acts of 1982, being sections 10.81 and 10.82 of the Michigan
3 Compiled Laws, are amended to read as follows:

4 Sec. 1. As used in this act:

5 ~~(a) "Energy administration" means the energy administration~~
6 ~~created pursuant to executive directives 1976-2 and 1976-5.~~

1 (A) ~~(b)~~ "Energy advisory committee" means the committee
2 created under section 2.

3 (B) ~~(c)~~ "Energy emergency" means a condition of danger to
4 the health, safety, or welfare of the citizens of this state due
5 to an impending or present energy shortage.

6 (C) ~~(d)~~ "Energy resource" means electricity, natural gas,
7 synthetic gas, a petroleum product including a liquefied petro-
8 leum gas, coal, wood fuel, geothermal source, ~~hydro power~~
9 HYDROPOWER, nuclear material, or other source producing power or
10 heat.

11 (D) ~~(e)~~ "Energy resource supplier" means a person who fur-
12 nishes an energy resource for the public at the wholesale or
13 retail level.

14 (E) ~~(f)~~ "Energy shortage" means lack of adequate available
15 energy resources in the state, or any part of the state, as
16 determined by the energy advisory committee or the governor.

17 (F) ~~(g)~~ "Person" means an individual, partnership, corpo-
18 ration, organization, or association of any kind.

19 Sec. 2. (1) An energy advisory committee is created. The
20 committee shall consist of the director of commerce, ~~the direc-~~
21 ~~tor of the energy administration,~~ the director of the department
22 of agriculture, the chairperson of the Michigan public service
23 commission, the director of public health, the director of trans-
24 portation, and the director of the department of state police.
25 The governor shall designate 1 of the ~~7~~ 6 members of the energy
26 advisory committee as chairperson of the committee.

1 (2) The energy advisory committee shall notify the governor
2 of an impending energy emergency. The energy advisory committee
3 shall determine whether an energy emergency is imminent on the
4 basis of information available to the energy advisory committee
5 from the Michigan public service commission, ~~the energy~~
6 ~~administration,~~ other state agencies, federal agencies, and
7 other sources of information including computer information
8 systems.
