HOUSE BILL No. 5040

September 20, 1989, Introduced by Rep. Bryant and referred to the Committee on Appropriations.

A bill to provide for loans for purchasing and installing irrigation equipment for persons engaged in farm operations; to prescribe certain duties of the department of agriculture; to require appropriations; and to provide for the promulgation of rules.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as "the
- 2 irrigation loan act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Department" means the department of agriculture.
- 5 (b) "Farmland" means land used in the commercial production 6 of farm products.
- 7 (c) "Farm products" means those plants useful to humans or
- 8 animals as food or for decorative purposes including,
- 9 limited to, forages and sod crops, grains and feed crops, fruits,

- 1 vegetables, flowers, seeds, grasses, trees, or other similar
 2 products.
- 3 (d) "Irrigation" means the artificial application of water
- 4 to farmland for the production of farm products.
- 5 (e) "Irrigation equipment" means machinery used in 6 irrigation.
- 7 (f) "Person" means an individual, corporation, partnership,
 8 association, or other legal entity.
- 9 Sec. 5. (!) The department shall provide a loan without
- 10 interest to be used for the purchase or installation of irriga-
- 11 tion equipment on a farm to a person who does all of the
- 12 following:
- (a) Applies on a form provided by the department.
- (b) Demonstrates to the satisfaction of the department that
- 15 the person is a resident of this state and is engaged in the com-

- 17 (c) Demonstrates to the satisfaction of the department that
- 18 the person is in need of a loan for the purchase or installation
- 19 of irrigation equipment.
- 20 (d) Demonstrates that the person is otherwise eligible under

- 22 (2) The department shall promulgate rules under the adminis-

- 26 dards for loans under this act. The department may promulgate

- 3 Sec. 7. (1) The legislature shall annually appropriate
- 4 money to the department for the purposes of this act.
- 5 (2) The department may accept gifts, grants, or donations
- 6 from any public or private source for the purposes of this act.
