- 1 Section 1. Section 309 of Act No. 86 of the Public Acts of

- 4 as follows:
- 5 Sec. 309. (1) A person shall not hunt deer with a bow and
- 6 arrow during the bow and arrow deer season without a bow and
- 7 arrow deer license. The fee for a resident bow and arrow deer
- 8 license shall be \$9.50. Beginning on April 1, 1987, the fee for
- 9 a resident bow and arrow deer license shall be \$12.50. The fee

- 1 for a nonresident bow and arrow deer license shall be \$50.00.
- 2 Beginning on April 1, 1986, the fee for a nonresident bow and
- 3 arrow deer license shall be \$75.00. The resident bow and arrow
- 4 deer license fee for a minor child shall be 1/2 the amount pre-
- 5 scribed in this subsection. Beginning on April 1, 1986, a A
- 6 person may purchase a second bow and arrow deer license in 1
- 7 season. The second bow and arrow deer license shall only be for
- 8 a male deer with antlers extending not less than 3 inches above
- 9 the skull. The fee for a second resident bow and arrow deer
- 10 license shall be \$9.50. Beginning on April 1, 1987, the fee for
