September 21, 1989, Introduced by Reps. Bennett, Richard A. Young, Ciaramitaro, Gire, Gubow, Profit, Honigman, Wallace, Keith, Brown, DeMars, Berman, Runco and Weeks and referred to the Committee on Agriculture.

A bill to require the labeling of certain milk products produced by cows treated with certain hormones; to provide for the powers and duties of certain state agencies and officials; and to prescribe penalties and provide remedies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "BST" means bovine somatotropin.
- 3 (b) "Milk products" means cream, light cream, coffee cream,
- 4 table cream, whipping cream, light whipping cream, heavy cream,
- 5 heavy whipping cream, whipped cream, whipped light cream, whipped
- 6 coffee cream, whipped table cream, sour cream, cultured sour
- 7 cream, half-and-half, sour half-and-half, cultured half-and-half,
- 8 reconstituted or recombined milk and milk products, concentrated
- 9 milk, concentrated milk products, skim milk, skimmed milk, lowfat
- 10 milk, fortified milk and milk products, vitamin D milk and milk

- 1 products, homogenized milk, flavored milk or milk products,
- 2 buttermilk, cultured buttermilk, cultured milk, cultured whole
- 3 milk buttermilk, acidified milk and milk products, cheese, cot-
- 4 tage cheese, creamed cottage cheese, butter, dry milk, dry
- 5 skimmed milk, eggnog, and any other final milk product.
- 6 (c) "Person" means an individual, partnership, corporation,

- 8 Sec. 2. The container or packaging used for milk products
- 9 produced by cows treated with BST sold or offered for sale in

- 13 Sec. 3. (1) A person who violates this act is responsible
- 14 to the state for a civil fine of not less than \$5,000.00 per

- (2) Milk products that are not labeled in the manner

- 18 by the department of agriculture.
- 19 (3) A default in the payment of a civil fine or costs
