THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 261 of Act No. 431 of the Public Acts of

- 4 as follows:
- 5 Sec. 261. (1) The department shall provide for the purchase

- 8 TRAVEL ARRANGEMENT SERVICES, printing, and all other items as
- 9 needed by state agencies for which the legislature has not

- 1 otherwise expressly provided. In all purchases made by the
- 2 department, all other things being equal, preference shall be
- 3 given to products manufactured or services offered by
- 4 Michigan-based firms, where consistent with federal statutes.
- 5 The department shall solicit competitive bids from the private
- 6 sector whenever practicable to efficiently and effectively meet
- 7 the state's needs. The department shall first determine that
- 8 competitive solicitation of bids in the private sector is not
- 9 appropriate before it shall use any other procurement method for
- 10 an acquisition.
- 11 (2) The department shall make all discretionary decisions
- 12 concerning the solicitation, award, amendment, cancellation, and
- 13 appeal of state contracts.
- 14 (3) The department shall utilize competitive bidding for all
- 15 purchases authorized pursuant to subsection (1) unless the
- 16 department has determined that another procurement method is in
- 17 the state's best interests.
- 18 (4) The department may delegate its procurement authority to
- 19 other state agencies within dollar limitations and for designated
- 20 types of procurements. The department may withdraw delegated
- 21 authority upon a finding that a state agency did not comply with
- 22 departmental procurement directives.
- 23 (5) The department may enter into lease purchases or
- 24 installment purchases for periods not exceeding the anticipated
- 25 useful life of the items purchased unless otherwise prohibited by

- (6) The department shall issue directives for the
- 2 procurement, receipt, inspection, and storage of supplies,
- 3 materials, and equipment, and for printing and services needed by
- 4 state agencies. The department shall provide standard specifica-
- 5 tions and standards of performance applicable to purchases.
