HOUSE BILL No. 5124

October 2, 1989, Introduced by Reps. Nye, Bender, Sparks, Emmons and Muxlow and referred to the Committee on Economic Development and Energy.

A bill to amend the title and section 2 of Act No. 62 of the Public Acts of 1963, entitled as amended "Industrial development revenue bond act of 1963," as amended by Act No. 153 of the Public Acts of 1985, being section 125.1252 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. The title and section 2 of Act No. 62 of the Public Acts of 1963, as amended by Act No. 153 of the Public Acts of 1985, being section 125.1252 of the Michigan Compiled Laws, 4 are amended to read as follows:

- An act relating to industrial development; to authorize
 municipalities to acquire and dispose of industrial buildings and
 sites and industrial machinery and equipment, including water and
 air pollution control equipment, solid waste disposal facilities,

- (b) "Municipality" means a county, city, incorporated vil-

- 23 (d) "Industrial machinery and equipment" means -such-
- 24 machinery and equipment, including water and air pollution con-

- 10 ing the temperature of any of the foregoing, or any liquid, gas,
- 11 or solid, resulting from any of the following: (i) Any process
- 12 of industry, manufacture, trade, or business; ... (ii) The THE
- 13 development, processing, or recovery of any natural resources;
- 14 (iii) The OR THE operation of any public utility , any of
- 15 which THAT may pollute or may tend to pollute or affect the
- 16 water or air of or adjacent to the state. "Water and air pollu-
- 17 tion control equipment" includes buildings, plants, structures,
- 18 facilities, and equipment and their appurtenances, together with
- 19 lands or interest in lands therefor or a portion thereof, used or
- 20 to be used as a change in manufacturing, production, generation,
- 21 transmission, or distribution process to prevent, reduce, recov-
- 22 er, remove, disperse, neutralize, control, or eliminate air or
- 23 water pollution. The term includes any and all buildings,
- 24 plants, structures, equipment, or facilities and their appurte-
- 25 nances, together with lands or interest in lands therefor or a
- 26 portion thereof, -which THAT qualify as air or water pollution

- 3 (f) "Public utility" means a person, firm, or corporation
- 4 engaged in the manufacture, production, generation, or distribu-
- 5 tion of electricity, steam heat, gas, or any combination thereof,
- 6 for sale to the public.
- 7 (g) "Solid waste disposal facilities" means buildings,
- 8 plants, structures, equipment, or facilities and their appurte-
- 9 nances, together with lands or interest in lands therefor or a
- 10 portion thereof, for the purpose of treating, shredding, compres-
- 11 sion, high temperature incineration, pyrolization, separation, or
- 12 any other technology for recovery, transporting, storing, or the
- 13 final placement and disposal of solid wastes resulting from any
- 14 of the following: (i) Any process of industry, manufacture,
- 15 trade, or business; ... (ii) The THE development, processing, or
- 16 recovery of any natural resources; -. (iii) The OR THE opera-
- 17 tion of any public utility. "Solid waste disposal facilities"
- 18 includes any and all buildings, plants, structures, equipment, or
- 19 facilities and their appurtenances, together with lands or inter-
- 20 est in lands therefor or a portion thereof, -which- THAT qualify
- 21 as solid waste disposal facilities under FORMER section 103(c)(4)
- 22 OR SECTION 142 of the -federal internal revenue code.
- 23 (h) "Pollution control facilities" means water and air pol-
- 24 lution control equipment and solid waste disposal facilities or
- 25 any of them.
- 26 (i) "Employee-owned corporation" means an employee-owned
- 27 corporation as defined by the employee-owned corporation act, ACT
