

HOUSE BILL No. 5162

October 10, 1989, Introduced by Rep. Joe Young, Jr. and referred to the Committee on State Affairs.

A bill to amend section 25 of Act No. 152 of the Public Acts of 1979, entitled as amended "State license fee act," as amended by Act No. 461 of the Public Acts of 1988, being section 338.2225 of the Michigan Compiled Laws; and to add section 26.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 25 of Act No. 152 of the Public Acts of
