

# HOUSE BILL No. 5230

October 24, 1989, Introduced by Reps. Hertel, Varga, Perry Bullard, Ouwinga, Ciaramitaro, Giese, Muxlow, Emerson, DeLange, Hoekman, Bankes, Watkins, London, DeBeaussiaert, Martin, DeMars, Jonker and Berman and referred to the Committee on Appropriations.

A bill to amend Act No. 1 of the Public Acts of the Extra Session of 1936, entitled as amended

"Michigan employment security act,"

being sections 421.1 to 421.73 of the Michigan Compiled Laws, by adding section 6f.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 1 of the Public Acts of the Extra  
2 Session of 1936, being sections 421.1 to 421.73 of the Michigan  
3 Compiled Laws, is amended by adding section 6f to read as  
4 follows:

5 SEC. 6F. (1) THERE SHALL BE APPROPRIATED \$2,700,000.00 FOR  
6 THE FISCAL YEAR ENDING SEPTEMBER 30, 1990, TO FUND IMPROVEMENTS  
7 IN THE COMMISSION HEADQUARTERS' OFFICES IN DETROIT. THESE FUNDS  
8 SHALL BE EXPENDED UPON APPROVAL BY THE COMMISSION AS FOLLOWS:

1 (A) \$950,000.00 FOR ELEVATOR MODERNIZATION.

2 (B) \$1,200,000.00 FOR FIRE SUPPRESSION AND ALARM SYSTEMS.

3 (C) \$550,000.00 FOR EXTERIOR AND OTHER REPAIRS.

4 (2) THIS APPROPRIATION SHALL BE CONSIDERED A WORK PROJECT  
5 AND SHALL NOT LAPSE AT THE END OF THE CURRENT FISCAL YEAR BUT  
6 SHALL CONTINUE TO BE AVAILABLE FOR EXPENDITURE UNTIL THE PROJECT  
7 IS COMPLETED.

8 Section 2. This amendatory act shall not take effect unless  
9 all of the following bills of the 85th Legislature are enacted  
10 into law:
