- 7 MICROWAVE OVEN, WASHER, DRYER, DISHWASHER, TRASH COMPACTOR, ROOM
- 8 AIR CONDITIONER, TELEVISION, STEREO, OR OTHER ELECTRONIC
- 9 COMPONENT OR DEVICE.

- 1 (B) "SERVICE DEALER" MEANS A PERSON WHO, FOR COMPENSATION,
- 2 PROVIDES REPAIR OR MAINTENANCE SERVICE ON AN APPLIANCE NOT OWNED

- 16 (5) UPON A SUIT BROUGHT BY A CUSTOMER AGAINST A SERVICE
- 17 DEALER IN A COURT OF COMPETENT JURISDICTION, A SERVICE DEALER
- 18 FOUND NOT COMPLYING WITH THIS SECTION IS LIABLE FOR THE GREATER
- 19 OF EITHER OF THE FOLLOWING:
- 20 (A) ACTUAL DAMAGES TO THE CUSTOMER.
- 21 (B) TWO HUNDRED DOLLARS PLUS REASONABLE ATTORNEY FEES.
