THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 328 of the Public Acts of 1931, as
- 2 amended, being sections 750.1 to 750.568 of the Michigan Compiled
- 3 Laws, is amended by adding section 224e to read as follows:
- 4 SEC. 224E. (1) A PERSON SHALL NOT KNOWINGLY MANUFACTURE,
- 5 SELL, DISTRIBUTE, OR POSSESS OR ATTEMPT TO MANUFACTURE, SELL,
- 6 DISTRIBUTE, OR POSSESS A SHOTGUN THAT IS CAPABLE OF HOLDING 6 OR
- 7 MORE ROUNDS OF AMMUNITION.

- (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A
- 2 FELONY, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS, OR
- 3 A FINE OF NOT MORE THAN \$2,000.00, OR BOTH.
- 4 (3) THIS SECTION DOES NOT APPLY TO ANY OF THE FOLLOWING:

- 5 STATES CODE TO ACQUIRE, HOLD, OR DISPOSE OF FIREARMS AS CURIOS OR
- 6 RELICS.
