- 7 (A) "AUCTION" MEANS THE SALE OR OFFER FOR SALE BY BIDDING OF

- 3 (C) "AUCTIONEER" MEANS AN INDIVIDUAL WHO, FOR COMPENSATION,
- 4 IS ENGAGED IN THE BUSINESS OF OR OFFERS TO ENGAGE IN THE BUSINESS
- 5 OF THE CONDUCT OF AN AUCTION.
- 6 SEC. 3203. (1) THERE IS CREATED A BOARD OF AUCTIONEERS.
- 7 (2) NOTWITHSTANDING SECTION 301, 6 MEMBERS OF THE INITIAL
- 8 BOARD SHALL BE MEMBERS OF A PROFESSIONAL ORGANIZATION IN THIS
- 9 STATE WHICH HAS FOR ITS PURPOSE THE ESTABLISHING AND MAINTAINING
- 10 OF STANDARDS OF PROFESSIONAL CONDUCT RELATING TO AUCTIONEERS AND
- 11 WHO FULFILL ALL OF THE FOLLOWING CONDITIONS:

- 26 ACQUIRE THE REAL OR PERSONAL PROPERTY SOLELY FOR THE PURPOSE OF
- 27 RESALE BY AUCTION.

- 1 (B) THE SALE OF REAL OR PERSONAL PROPERTY BY AUCTION IS
- 2 CONDUCTED FOR THE BENEFIT OF A CHARITABLE, RELIGIOUS, OR CIVIC
- 3 ORGANIZATION AND THE AUCTIONEER CONDUCTING THE AUCTION RECEIVES
- 4 NO COMPENSATION.
- 5 (C) THE SALE OF REAL OR PERSONAL PROPERTY BY AUCTION IS CON-
- 6 DUCTED BY AN AGENT OR EMPLOYEE OF A COURT OF COMPETENT JURISDIC-
- 7 TION PURSUANT TO A COURT ORDER.
- 8 SEC. 3207. THE DEPARTMENT SHALL ISSUE A LICENSE AS AN
- 9 APPRENTICE AUCTIONEER TO AN INDIVIDUAL WHO MEETS ALL OF THE FOL-
- 10 LOWING CONDITIONS:
- 11 (A) IS NOT LESS THAN 18 YEARS OF AGE.
- 12 (B) IS OF GOOD MORAL CHARACTER.
- 13 (C) HAS HAD AN EDUCATION EQUIVALENT TO THE COMPLETION OF
- 14 HIGH SCHOOL.
- 15 (D) HAS COMPLETED NOT LESS THAN 40 CLOCK HOURS OF CLASSROOM
- 16 STUDY RELATED TO THE BUSINESS OF THE CONDUCT OF AN AUCTION. THE
- 17 CLASSROOM STUDY SHALL BE APPROVED BY THE BOARD AND THE
- 18 DEPARTMENT.
- 19 (E) HAS COMPLETED AN EXAMINATION AS DESCRIBED IN
- 20 SECTION 3215 IN THE CASE OF INITIAL LICENSURE AND HAS COMPLIED
- 21 WITH THE CONTINUING EDUCATION REQUIREMENTS OF SECTION 3217 IN THE

- 26 LICENSED PRINCIPAL AUCTIONEER CONFIRMING EMPLOYMENT OF THE

- 3 SEC. 3209. THE DEPARTMENT SHALL ISSUE A LICENSE AS A PRIN-
- 4 CIPAL AUCTIONEER TO AN INDIVIDUAL WHO MEETS ALL OF THE FOLLOWING
- 5 CONDITIONS:
- 6 (A) HAS BEEN LICENSED AS AN APPRENTICE AUCTIONEER FOR A
- 7 PERIOD OF NOT LESS THAN ! YEAR, DURING WHICH TIME HE OR SHE HAS
- 8 ACTIVELY PARTICIPATED IN THE CONDUCTING OF NOT LESS THAN 5
- 9 AUCTIONS. THE EXPERIENCE SHALL BE VERIFIED BY AN AFFIDAVIT OF A
- 10 PRINCIPAL AUCTIONEER AND SHALL PROVIDE THE NAMES AND ADDRESSES OF
- 11 THE PARTIES ON WHOSE BEHALF THE AUCTION WAS HELD AND THE DATES OF

- 13 (B) HAS OBTAINED A BOND AS DESCRIBED IN SECTION 3219, IF A
- 14 BOND IS REQUIRED.
- 15 (C) HAS COMPLETED AN EXAMINATION AS DESCRIBED IN
- 16 SECTION 3215 IN THE CASE OF INITIAL LICENSURE AND HAS COMPLIED
- 17 WITH THE CONTINUING EDUCATION REQUIREMENTS OF SECTION 3217 IN THE
- 18 CASE OF A RENEWAL OF A LICENSE.
- 19 (D) IS OF GOOD MORAL CHARACTER.
- 20 SEC. 3211. (1) THE DEPARTMENT SHALL ISSUE A LICENSE TO A
- 21 PERSON FOR THE OPERATION OF AN AUCTION GALLERY IF ALL OF THE FOL-
- 22 LOWING REQUIREMENTS ARE MET:
- 23 (A) AN APPLICATION IS MADE BY THE OWNERS OR MANAGERS OF THE
- 24 AUCTION GALLERY.
- 25 (B) THE APPLICATION INCLUDES A DRAWING OR DIAGRAM INDICATING
- 26 THE PREMISES TO BE LICENSED AND THE LOCATION OF ANY FACILITIES OR
- 27 EQUIPMENT REQUIRED BY ANY RULES PROMULGATED BY THE BOARD.

- (C) THE APPLICATION PROVIDES FOR OTHER INFORMATION
- 2 CONCERNING THE PREMISES INCLUDING, BUT NOT LIMITED TO, WHETHER
- 3 THE PREMISES ARE OWNED OR LEASED AND ANY ZONING AND USE RESTRIC-
- 4 TIONS IN EFFECT IN THE AREA WHERE THE PREMISES ARE LOCATED.
- 5 (D) A BOND OF THE TYPE DESCRIBED IN SECTION 3219 IS
- 6 OBTAINED, IF A BOND IS REQUIRED.
- 7 (2) IN THE CASE OF THE OWNERSHIP OF MORE THAN 1 AUCTION GAL-
- 8 LERY BY A PERSON, THE DEPARTMENT SHALL ISSUE A SEPARATE LICENSE
- 9 FOR EACH LOCATION UPON APPLICATION OF THE OWNER OR MANAGER FOR
- 10 LICENSURE OF EACH LOCATION IN THE MANNER DESCRIBED IN
- 11 SUBSECTION (1).
- 12 SEC. 3213. (1) AN AUCTION GALLERY LICENSED UNDER THIS ARTI-
- 13 CLE SHALL NOT ALLOW AN AUCTION TO BE CONDUCTED ON ITS PREMISES
- 14 UNLESS A WRITTEN CONTRACT IS EXECUTED BETWEEN THE AUCTION GALLERY
- 15 AND A LICENSED PRINCIPAL AUCTIONEER. A COPY OF THE CONTRACT
- 16 SHALL BE KEPT AS PART OF THE RECORDS OF THE AUCTION GALLERY AND,
- 17 UPON REQUEST, MAY BE INSPECTED BY A MEMBER OF THE GENERAL PUBLIC
- 18 DURING NORMAL BUSINESS HOURS.
- 19 (2) AN AUCTION GALLERY LICENSED UNDER THIS ARTICLE SHALL
- 20 MAINTAIN WRITTEN RECORDS OF EACH AUCTION SALE FOR A PERIOD OF NOT
- 21 LESS THAN 1 YEAR FROM THE DATE OF THE AUCTION SALE. THE RECORDS
- 22 SHALL INCLUDE, BUT NOT BE LIMITED TO, ALL OF THE FOLLOWING:
- 23 (A) CONSIGNMENT RECEIPTS.
- 24 (B) BIDDER REGISTRATIONS.
- 25 (C) DOCUMENTS RELATING TO FINAL SETTLEMENTS WITH
- 26 CONSIGNORS.

- 1 (3) AN AUCTION GALLERY LICENSED UNDER THIS ARTICLE SHALL
- 2 MAINTAIN RECORDS ON ALL CURRENT EMPLOYEES AND ON PAST EMPLOYEES
- 3 FOR NOT LESS THAN 3 YEARS AFTER A PAST EMPLOYEE LEAVES THE
- 4 EMPLOYMENT OF THE AUCTION GALLERY, WHICH RECORDS SHALL INCLUDE
- 5 THE EMPLOYEE'S NAME, ADDRESS, SOCIAL SECURITY NUMBER, AND DATE OF
- 6 BIRTH.
- 7 (4) AN AUCTION GALLERY LICENSED UNDER THIS ARTICLE SHALL
- 8 CONSPICUOUSLY POST ON THE LICENSED PREMISES A COPY OF THE LICENSE
- 9 ISSUED UNDER THIS ARTICLE.
- 10 (5) AN AUCTION GALLERY LICENSED UNDER THIS ARTICLE SHALL
- 11 ESTABLISH AN ESCROW ACCOUNT IN THE MANNER DESCRIBED BY RULES
- 12 PROMULGATED BY THE DEPARTMENT AND BOARD. ALL CHECKS, DRAFTS,
- 13 NEGOTIABLE INSTRUMENTS, AND CASH TENDERED BY A BUYER FOR THE PAY-
- 14 MENT OF AN ITEM THE AUCTION GALLERY SOLD BY AUCTION SHALL BE
- 15 DEPOSITED IN THE ESCROW ACCOUNT. THE AUCTION GALLERY SHALL MAKE
- 16 A DISBURSEMENT RELATIVE TO A SALE BY AUCTION THROUGH THAT ESCROW
- 17 ACCOUNT IN THE TIME PERIOD AND MANNER DESCRIBED BY THOSE RULES.
- 18 (6) THE DEPARTMENT AND THE BOARD MAY, UPON NOTICE GIVEN TO A
- 19 LICENSED AUCTION GALLERY, INSPECT THE RECORDS REQUIRED TO BE KEPT
- 20 PURSUANT TO THIS SECTION.
- 21 SEC. 3215. (1) THE DEPARTMENT AND THE BOARD SHALL DEVELOP
- 22 AN EXAMINATION FOR APPLICANTS FOR LICENSURE UNDER THIS ARTICLE OR
- 23 MAY ADOPT AN EXAMINATION DEVELOPED BY AN ORGANIZATION INVOLVED IN
- 24 THE TRAINING OF AUCTIONEERS IF THAT EXAMINATION IS DETERMINED BY
- 25 THE BOARD TO SUFFICIENTLY TEST THE KNOWLEDGE AND SKILLS RELATIVE
- 26 TO THE BUSINESS OF THE CONDUCT OF AUCTIONS. A SEPARATE

- 6 (A) THE PROVISIONS OF THIS ARTICLE.
- 7 (B) ETHICS AND ETHICAL PRACTICES AS THEY RELATE TO THE BUSI-
- 8 NESS OF CONDUCTING AUCTIONS.
- 9 (C) ELEMENTARY MATHEMATICS.
- 10 (D) ELEMENTARY PRINCIPLES OF LAND ECONOMICS.
- 11 (E) ELEMENTARY PRINCIPLES OF THE LAW REGARDING BULK SALES,
- 12 DEEDS, MORTGAGES, CONTRACTS OF SALE, AGENCY, LEASES, AUCTIONS,
- 13 AND BROKERAGE.
- 14 (3) THE DEPARTMENT SHALL ADMINISTER THE EXAMINATIONS ON AT
- 15 LEAST A QUARTERLY BASIS. THE DEPARTMENT MAY ADMINISTER THE EXAM-
- 16 INATIONS MORE OFTEN THAN ON A QUARTERLY BASIS IF THE BOARD DETER-
- 17 MINES THAT CIRCUMSTANCES EXIST THAT WARRANT THE FURTHER ADMINIS-
- 18 TRATION OF THE EXAMINATION.
- 19 SEC. 3217. (1) THE BOARD SHALL PROMULGATE RULES SETTING
- 20 STANDARDS FOR MANDATORY PROGRAM CONTINUING EDUCATION. THE RULES
- 21 SHALL PROVIDE FOR NOT LESS THAN 4 CLOCK HOURS OF CONTINUING EDU-
- 22 CATION FOR EACH CLASS OF LICENSURE PER YEAR.
- 23 (2) THE BOARD SHALL PROMULGATE RULES CONCERNING RECORDS TO
- 24 BE MAINTAINED BY A PRINCIPAL AUCTIONEER AND THE REQUIREMENTS CON-
- 25 CERNING AN ESCROW ACCOUNT USED BY AN AUCTION GALLERY.
- 26 SEC. 3219. THE DEPARTMENT AND BOARD MAY PROMULGATE RULES
- 27 FOR A BOND TO BE OBTAINED AS A CONDITION OF INITIAL LICENSURE OR

- 1 RENEWAL OF LICENSURE BY LICENSEES UNDER THIS ARTICLE OR
- 2 APPLICANTS FOR LICENSURE. THE RULES SHALL DESCRIBE THE AMOUNT
- 3 AND TYPE OF COVERAGE FOR EACH CLASS OF LICENSEE.
- 4 SEC. 3221. (1) THE DEPARTMENT SHALL ISSUE A LICENSE WITHOUT
- 5 EXAMINATION TO A NONRESIDENT INDIVIDUAL WHO, AT THE TIME OF
- 6 APPLICATION, IS LICENSED, REGISTERED, CERTIFIED, OR OTHERWISE
- 7 REGULATED BY ANOTHER STATE IF THE REQUIREMENTS OF THAT STATE, AS
- 8 DETERMINED BY THE BOARD AND THE DEPARTMENT, ARE SUBSTANTIALLY THE
- 9 EQUIVALENT OF THE REQUIREMENTS OF THIS ARTICLE AND IF THE OTHER
- 10 STATE OFFERS LICENSURE, CERTIFICATION, OR REGISTRATION ON A BASIS
- 11 SIMILAR TO THIS SECTION TO LICENSEES UNDER THIS ARTICLE.
- 12 (2) A NONRESIDENT SHALL FILE AN IRREVOCABLE CONSENT TO SERV-
- 13 ICE OF PROCESS WHICH CONSENT SHALL BE SIGNED BY THE LICENSEE. A
- 14 PROCESS OR PLEADING SERVED UPON THE DEPARTMENT SHALL BE SUFFI-
- 15 CIENT SERVICE UPON THE LICENSEE. A PROCESS OR PLEADING SERVED
- 16 UPON THE DEPARTMENT UNDER THIS SECTION SHALL BE IN DUPLICATE.
- 17 THE DEPARTMENT SHALL IMMEDIATELY SERVE BY REGISTERED OR CERTIFIED
- 18 MAIL A COPY OF THE PROCESS OR PLEADING TO THE LICENSEE'S LAST
- 19 KNOWN ADDRESS AS DETERMINED BY THE RECORDS OF THE DEPARTMENT.
- 20 SEC. 3223. THE DEPARTMENT SHALL LICENSE AS A PRINCIPAL AUC-
- 21 TIONEER, AFTER VERIFICATION OF THE EXPERIENCE REQUIREMENTS
- 22 IMPOSED IN SUBDIVISION (A), AN INDIVIDUAL WHO APPLIES NOT MORE
- 23 THAN 2 YEARS AFTER THE AMENDATORY ACT THAT ADDED THIS ARTICLE AND
- 24 WHO FULFILLS ALL OF THE FOLLOWING CONDITIONS:
- 25 (A) SUBMITS AN AFFIDAVIT ATTESTING TO EXPERIENCE IN THE
- 26 PRACTICE OF THE CONDUCT OF AUCTIONS FOR NOT LESS THAN 3 YEARS

- 1 BEFORE THE EFFECTIVE DATE OF THIS ARTICLE, WHICH EXPERIENCE SHALL
- 2 HAVE INCLUDED THE CONDUCT OF NOT LESS THAN 12 AUCTIONS.
- 3 (B) SUBMITS PROOF OF RESIDENCY IN THIS STATE.
- 4 (C) SUBMITS PROOF OF OBTAINING THE APPROPRIATE BOND AS
- 5 DESCRIBED IN SECTION 3219, IF A BOND IS REQUIRED.
- 6 SEC. 3225. A LICENSEE WHO COMMITS ANY OF THE FOLLOWING ACTS
- 7 SHALL BE SUBJECT TO THE PENALTIES CONTAINED IN ARTICLE 6:
- 8 (A) FAILS TO ENTER INTO A WRITTEN CONTRACT WITH A SELLER OR
- 9 CONSIGNOR PRIOR TO PLACING OR AUTHORIZING ANY ADVERTISING FOR AN
- 10 AUCTION.
- 11 (B) FAILS TO REDUCE TO WRITING OR FAILS TO ISSUE ANY APPRO-
- 12 PRIATE DOCUMENTATION RELATIVE TO AN AUCTION-RELATED TRANSACTION.
- 13 (C) FAILS TO APPROPRIATELY USE OR ISSUE PAYMENT FROM AN
- 14 ESCROW FUND.
- 15 (D) IN THE CASE OF AN AUCTION GALLERY, PERMITS AN UNLICENSED
- 16 AUCTIONEER TO CONDUCT AN AUCTION ON THE LICENSED PREMISES.
- 17 (E) IN THE CASE OF A PRINCIPAL AUCTIONEER, FAILS TO PROPERLY
- 18 SUPERVISE AN APPRENTICE AUCTIONEER IN HIS OR HER EMPLOY.
- 19 (F) IN THE CASE OF AN APPRENTICE AUCTIONEER, ACCEPTS PAYMENT
- 20 OR COMPENSATION FROM A PERSON OTHER THAN THE PRINCIPAL AUCTIONEER
- 21 BY WHOM HE OR SHE IS EMPLOYED.
- 22 (G) VIOLATES THE REQUIREMENTS OF THIS ARTICLE OR A RULE
- 23 PROMULGATED UNDER THIS ARTICLE.
- 24 SEC. 3227. (1) ANY PROVISION OF AN ORDINANCE OR LAW OF A
- 25 LOCAL GOVERNMENTAL UNIT WHICH IS INCONSISTENT OR IN CONFLICT WITH
- 26 THIS ARTICLE IS SUPERSEDED TO THE EXTENT OF THE INCONSISTENCY OR
- 27 CONFLICT.

- 1 (2) A LOCAL GOVERNMENTAL UNIT SHALL NOT CHARGE LICENSURE
- 2 FEES IN ADDITION TO THE FEES REQUIRED UNDER THIS ARTICLE.
- 3 (3) AS USED IN THIS SECTION, "LOCAL GOVERNMENTAL UNIT" MEANS
- 4 A COUNTY, CITY, TOWNSHIP, OR VILLAGE.
- 5 Section 2. This amendatory act shall not take effect unless
