THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 2619 of Act No. 368 of the Public Acts
- 2 of 1978, as added by Act No. 82 of the Public Acts of 1984, being

- 5 Sec. 2619. (1) The department shall establish a registry to
- 6 record cases of cancer and other specified tumorous and precan-

- 1 necessary and appropriate in order to conduct epidemiologic
- 2 surveys of cancer and cancer-related diseases in the state.
- 3 (2) Each diagnosed case of cancer and other specified tumor-
- 4 ous and precancerous diseases shall be reported to the department
- 5 pursuant to subsection (4), or reported to a cancer reporting
- 6 registry if the cancer reporting registry meets standards estab-
- 7 lished pursuant to subsection (4) to ensure the accuracy and com-
- 8 pleteness of the reported information. A person or facility
- 9 required to report a diagnosis pursuant to subsection (4) may
- 10 elect to report the diagnosis to the state through an existing
- 11 cancer registry only if the registry meets minimum reporting
- 12 standards established by the department.
- 13 (3) The department shall maintain comprehensive records of

- 7 ysis of, and research related to, the epidemiologic data required

- 9 (7) Within 2 years after the effective date of this
- 10 section BY JULY 1, 1986, the department shall begin evaluating
- 11 the reports collected pursuant to subsection (2). The department
- 12 shall publish and make available to the public reports summariz-
- 13 ing the information collected. The first summary report shall be
- 14 published not later than 180 days after the end of the first 2
- 15 full calendar years after the effective date of this section
- 16 JULY 1, 1984. Subsequent annual summary reports shall be made on
- 17 a full calendar year basis and published not later than 180 days

- 19 (8) Reporting pursuant to subsection (2) shall begin the
