# **HOUSE BILL No. 5486**

### EXECUTIVE BUDGET BILL

February 14, 1990, Introduced by Reps. Jacobetti and Joe Young, Sr. and referred to the Committee on Appropriations.

A bill to make appropriations for the department of mental health and certain state purposes related to mental hygiene for the fiscal year ending September 30, 1991; to provide for the expenditure of such appropriations; to create funds; to provide for reports; to prescribe the powers and duties of certain state agencies and departments; and to provide for disposition of fees and other income received by the various state agencies.
