EXECUTIVE BUDGET BILL

February 14, 1990, Introduced by Reps. Jacobetti and Hood and referred to the Committee on Appropriations.

A bill to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 1991; to provide for the expenditures of those appropriations; and to prescribe the powers and duties of certain state departments, institutions, agencies, and officers.

GENERAL SECTIONS

04934'90

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending in this appropriation act is \$1,255,295,300.00. There are no state appropriations to be paid to local units of government in section 101.

17 Sec. 202. (1) The sums appropriated in this act shall be paid out of the 18 state treasury and shall be distributed by the state treasurer to the respective institutions in 12 monthly installments, except for the Martin 19 20 Luther King, Jr.-Cesar Chavez-Rosa Parks programs which shall receive 21 distributions in quarterly installments. If the appropriations for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks programs are not committed or awarded 22 23 by April 1, 1991 the funds shall become subject to legislative transfer. Any 24 unexpended and unencumbered funds remaining on September 30, 1991 from the 25 amount appropriated for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks 26 programs shall lapse on September 30, 1991 and shall be returned to the state

- 1 general fund. The amount distributed to an institution shall not exceed the 2 net appropriations plus additional distributions specifically authorized by 3 this act.
- (2) Each institution shall receive payments providing the same percentage increase in its 1990-91 institutional fiscal year over its 1990-91 fiscal year as the percentage increase in state appropriations to each institution for the state fiscal year 1990-91 over 1989-90, based on the appropriations and scheduled allotments provided under Act No. 325 of the Public Acts of 1988 and 9 Act No. 195 of the Public Acts of 1989.
- (3) A detailed description of procedures utilized to arrive at the amounts appropriated in section 101 shall be submitted to each institution by the senate and house fiscal agencies. That description shall include, but is not limited to, a detailed expenditure history of the student equity plan that was initially implemented in the fiscal year ending September 30, 1988. The expenditure history shall be calculated for each recipient institution based on HEIDI expenditure data.
- 17 (4) From the amounts appropriated in section 101, institutions shall 18 reimburse the Michigan public school employees' retirement system at the rate 19 of 9.0% of retirement members' salaries.
- Sec. 203. (1) All colleges and universities shall furnish all program and 21 financial information that is required by and in a manner prescribed by the 22 state budget director or the house and senate appropriations committees.
- 23 (2) Pursuant to section 4 of article VIII of the state constitution of 24 1963, all state institutions of higher education shall furnish an annual 25 accounting of all income and expenditures to the legislature and the state 26 budget director.

- 1 Sec. 204. Money received by the state from the federal government or
- 2 private sources for the use of a college or university is appropriated for the
- 3 purpose for which it was provided. The acceptance and use of federal or
- 4 private funds shall not place an obligation upon the legislature to continue
- 5 the purposes for which the funds are made available.
- 6 Sec. 205. The appropriations contained in this act shall not be used for
- 7 the construction of buildings or operations of institutions of higher education
- 8 not expressly authorized in section 101.
- 9 Sec. 206. The appropriations in this act are subject to section 391 of
- 10 the management and budget act, Act No. 431 of the Public Acts of 1984, being
- 11 section 18.1391 of the Michigan Compiled Laws.
- 12 Sec. 207. Each institution that is appropriated funds under this act
- 13 shall comply with requests for data made by the Michigan postsecondary
- 14 education database policy council.
- 15 Sec. 208. The appropriations contained in this act shall not be expended
- 16 for renting, purchasing, or showing any movie film determined to be obscene
- 17 pursuant to Miller v California, 413 U.S. 15 (1973).
- 18 GRANTS AND FINANCIAL AID
- 19 Sec. 301. Payments of the amounts included in section 101 for the state
- 20 competitive scholarship program established under Act No. 208 of the Public
- 21 Acts of 1964, being sections 390.971 to 390.981 of the Michigan Compiled Laws,
- 22 shall be made as follows:
- 23 (a) \$1,200.00 maximum per award in accordance with section 3(1) of Act No.
- 24 208 of the Public Acts of 1964, being section 390.973 of the Michigan Compiled
- 25 Laws.
- 26 (b) \$24,313,300.00 total state general fund.

- 1 (c) If a student who receives an award under this section for academic
- 2 year 1990-91 has his or her tuition and fees paid under the Michigan education
- 3 trust program and still has financial need, the funds awarded under this
- 4 section may be used for educational expenses other than tuition and fees.
- 5 Sec. 302. (1) The amounts appropriated in section 101 for the state
- 6 tuition grant program established under Act No. 313 of the Public Acts of 1966,
- 7 being sections 390.991 to 390.997a of the Michigan Compiled Laws, shall not
- 8 exceed the following:
- 9 (a) \$2,300.00 maximum per grant.
- 10 (b) \$48,938,900.00 total state general fund.
- 11 (2) Tuition grant awards shall be made to all eligible Michigan residents
- 12 who apply before September 1, 1990, and who are qualified.
- 13 (3) The Michigan higher education assistance authority shall determine an
- 14 actual maximum tuition grant award amount per student that ensures that the
- 15 aggregate payments for the tuition grant program do not exceed the
- 16 appropriation contained in section 101 for the state tuition grant program.
- 17 (4) Any unexpended and unencumbered funds remaining on September 30, 1991
- 18 shall be distributed among late applicants, not to exceed the appropriated
- 19 amount in section 101.
- 20 (5) If a student who receives an award under this section for academic
- 21 year 1990-91 has his or her tuition and fees paid under the Michigan education
- 22 trust program and still has financial need, the funds awarded under this
- 23 section may be used for educational expenses other than tuition and fees.
- Sec. 303. Included in the appropriation in section 101 is funding for the
- 25 Michigan work study program established under Act No. 303 of the Public Acts of
- 26 1986, being sections 390.1321 to 390.1332 of the Michigan Compiled Laws. Of

- 1 the amount appropriated for the Michigan work study program, at least
- 2 \$500.000.00 shall be allocated for graduate work study. An effort should be
- 3 made by each institution participating in the Michigan work study program to
- 4 assure that not less than 10% of those undergraduate, graduate, and
- 5 professional students eligible to participate in the program are placed with
- 6 for-profit employers no later than December 31, 1989. The authority shall
- 7 submit a report to the clerk of the house and the secretary of the senate no
- 8 later than March 31, 1991, specifying the level of participation by each
- 9 institution, the barriers to the achievement of the 10% for-profit
- 10 participation level by each institution, and recommendations for addressing
- 11 those barriers.
- 12 Sec. 304. (1) Payments of the amounts included in section 101 for the
- 13 general degree reimbursement program established under Act No. 75 of the Public
- 14 Acts of 1974, being sections 390.1021 to 390.1027 of the Michigan Compiled
- 15 Laws, shall be made as follows:
- 16 (a) The reimbursement rate per eligible degree shall be the equally
- 17 prorated amount permitted by the appropriation, except that the amount of the
- 18 reimbursement for each associate degree shall be 1/2 of the rate of
- 19 reimbursement for each bachelor or master degree.
- 20 (b) Total general degree reimbursement payments shall not exceed
- 21 \$4,403,100.00.
- 22 (c) From the general degree reimbursement program, \$135,300.00 shall be
- 23 provided to Spring Arbor college for the southern Michigan state prison program.
- 24 (d) From the general degree reimbursement program, \$200,500.00 shall be
- 25 provided to the university of Detroit for graduate research aid.
- 26 (e) From the general degree reimbursement program, \$30,100.00 shall be 04934'90

- 1 provided to Marygrove college for learning clinics.
- 2 Sec. 305. Payments of the amounts included in section 101 for the allied
- 3 health degree reimbursement program established under Act No. 75 of the Public
- 4 Acts of 1974, being sections 390.1021 to 390.1027 of the Michigan Compiled
- 5 Laws, shall be made as follows:
- 6 (a) The reimbursement rate per eligible degree shall be the equally
- 7 prorated amount permitted by the appropriation.
- 8 (b) Total allied health degree reimbursement payments shall not exceed
- 9 \$690,100.00.
- 10 Sec. 306. (1) Funds disbursed through the degree reimbursement programs
- 11 shall not be used by any recipient institution for theology or divinity
- 12 programs.
- 13 (2) Each eligible institution shall be provided on October 1, 1990, or as
- 14 soon as possible thereafter, a preliminary payment of at least 75%, but not
- 15 more than 90%, of its estimated degree reimbursements under section 101. The
- 16 balance of the degree reimbursement to each eligible institution shall be
- 17 provided when the numbers of earned degrees conferred and total amounts to be
- 18 paid are certified.
- 19 Sec. 307. The funds appropriated in section 101 for the American Indian
- 20 tuition waiver reimbursement established under Act No. 174 of the Public Acts
- 21 of 1976, being sections 390.1251 to 390.1253 of the Michigan Compiled Laws, are
- 22 to reimburse tuition waivers granted by colleges before September 30, 1989.
- 23 Only those expenses classified as tuition assessments are eligible for
- 24 reimbursement, except that if a student who receives an award under this
- 25 section for academic year 1990-91 has his or her tuition and fees paid under
- 26 the Michigan education trust program and still has financial need, the funds

- 1 awarded under this section may be used for educational expenses other than
- 2 tuition and fees.
- 3 Sec. 308. Included in the appropriations in section 101 for higher
- 4 education are \$500,000.00 for the establishment of the Robert C. Byrd honors
- 5 scholarship program. Pursuant to the implementation of this program, the
- 6 legislature encourages the department of education to distribute funds for this
- 7 scholarship program to each high school in this state and to allow each high
- 8 school to select a merit scholar.
- 9 Sec. 309. To enable the legislature to evaluate the appropriation needs
- 10 of institutions of higher education, each independent college and university
- 11 shall make available to the legislature, upon request, data regarding grants
- 12 for the preceding, current, and ensuing fiscal years.
- 13 Sec. 310. The auditor general shall audit selected enrollments, degrees,
- 14 and awards at selected independent colleges and universities receiving awards
- 15 administered by the department of education. The audits shall be based upon
- 16 definitions and requirements established by the department of management and
- 17 budget and the senate and house fiscal agencies. The auditor general shall
- 18 submit a report of findings to the senate and house appropriations committees
- 19 not later than May 1, 1991.
- 20 STATE UNIVERSITIES
- 21 Sec. 401. The legislature encourages the development of an educational
- 22 reciprocity program between Lake Superior state university and the colleges of
- 23 northern Ontario, Canada.
- 24 Sec. 402. Student health services at state universities shall be
- 25 self-supporting through student and user fees.
- Sec. 403. (1) The auditor general shall audit enrollments at all public 04934'90

- 1 universities. The audits shall be based upon the definitions and requirements
- 2 established by the department of management and budget and the senate and house
- 3 fiscal agencies. The audits shall be based on uniform reporting categories and
- 4 shall include HEIDI data. The auditor general shall submit a report of
- 5 findings to the senate and house appropriations committees no later than March
- 6 1, 1991.
- 7 (2) Student credit hours reports shall not include the following:
- 8 (a) Student credit hours generated through correspondence courses, credit
- 9 by examination, or inmate prison programs regardless of teaching location.
- 10 (b) Student credit hours generated in new degree programs after January 1,
- 11 1975, that have not been specifically authorized for funding by the
- 12 legislature, except spin-off programs converted from existing core programs
- 13 that do all of the following:
- 14 (i) Represent new options, fields, or concentrations within existing
- 15 programs.
- (ii) Are consistent with the current institutional role and mission.
- 17 (iii) Are accommodated within the continuing funding base of the
- 18 institution.
- 19 (iv) Do not require a new degree level beyond that which the institution
- 20 is currently authorized to grant within that discipline or field.
- 21 (v) Do not require special grant funding from the state. As used in this
- 22 subparagraph, "special grant funding" means funding in addition to that
- 23 provided by the student credit hours generated within the program, either
- 24 before program initiation or within the first 3 years of program operation.
- 25 Sec. 404. Included in the amounts appropriated in section 101, there is
- 26 appropriated to Wayne state university the sum of \$440,000.00 for cooperative

- 1 leadership skills programs for trade union minorities and women. This program
- 2 is to be offered by a consortium consisting of eastern Michigan university,
- 3 Michigan state university, northern Michigan university, Oakland university,
- 4 university of Michigan, and Wayne state university. Wayne state university
- 5 shall act as fiscal agent, and the funds shall be divided among the
- 6 participating universities.
- 7 Sec. 405. Included in the amounts appropriated in section 101 are funds
- 8 for the following consortia projects:
- 9 (a) Northern inter-collegiate research sharing consortium central
- 10 Michigan university and Kirtland community college.
- 11 (b) Industrial development institute Michigan state university and
- 12 Lansing community college.

- 25 Sec. 406. The principal executive officer of each institution of higher
- 26 education receiving an appropriation under this act shall expend a portion of

- 1 the funds appropriated to the institution in reporting to the house and senate
- 2 appropriations committees, the auditor general, the senate and house fiscal
- 3 agencies, and the department of management and budget within 60 days after the

- 20 (3) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors
- 21 program funds shall be expended to increase the number of minority instructors
- 22 in the classroom and provide role models for underrepresented minority students.
- 23 (4) The presidents council of state universities shall report by October
- 24 30, 1990 to the house and senate appropriations committees, the office of
- 25 minority equity in postsecondary education, and the department of management
- 26 and budget all of the following Martin Luther King, Jr.-Cesar Chavez-Rosa Parks

- 1 visiting professors program information:
- 2 (a) Names of visiting professors.
- 3 (b) Courses instructed by visiting professors.

- 3 minority equity in postsecondary education the name and social security number
- 4 of each recipient of a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks
- 5 scholarship or fellowship, and the amount, date, and duration of the award.
- 6 (14) If any funds are not awarded or committed by a university to a
- 7 specific recipient by April 1, 1991, the department of management and budget
- 8 may recommend legislative transfers to other Martin Luther King, Jr.-Cesar
- 9 Chavez-Rosa Parks line items within a university or to Martin Luther King,

- 16 university is granted \$220,000.00 for the labor education service program.
- 17 (2) Included in the amounts contained in section 101, Oakland university
- 18 is granted \$30,000.00 for community services of Oakland.
- 19 Sec. 416. The legislature recognizes the value of cooperative programs
- 20 between state universities and community colleges aimed at stimulating economic
- 21 development and diversification in this state. It is the intent of the
- 22 legislature to encourage continued development and expansion of these
- 23 cooperative programs in the years ahead.
- 24 Sec. 417. It is the intent of the legislature that eastern Michigan
- 25 university shall coordinate a professional teacher development program for

- Sec. 419. It is the intent of the legislature in expending funds for the 8 operation of the D. J. Jacobetti vocational skill center that the following 9 activities be performed in order to insure that the integrity and the original 10 role set forth for the vocational skill center be retained:
- (a) Insuring the flexibility and adequate autonomy that will enable the vocational skill center to expand, upgrade, and modify its existing programs as well as to develop new vocational programs in partnership with its industrial, commercial, agency, and labor advisories. The length and content of programs at the skill center, whether they be certificate, 1-year, or 2-year, shall be determined by the performances required in the marketplace rather than by baccalaureate criteria.

- 13 shall submit a progress report to the house and senate higher education
- 14 appropriations subcommittees by March 1, 1991. The Japan center for Michigan
- 15 universities, which is located in Hikone, Japan, has the following 4 major
- 16 program components:
- 17 (a) Japanese language and culture studies for Michigan students.
- (b) English language studies for Japanese citizens.
- 19 (c) Workshops and seminars for Japanese and American businesses
- 20 and professional persons.
- 21 (d) Research by faculty and students.
- Sec. 425. Included in the appropriations in section 101 is funding for
- 23 the urban teacher education program. The amount appropriated shall be equally
- 24 divided between eastern Michigan university, Wayne state university, and Wayne
- 25 county community college for the sole purpose of development and implementation
- 26 of the urban teacher education program approved by the state board of

- 1 education. Not less than 75% of the allocation to each institution for the
- 2 urban teacher education program shall be spent for operation and support of
- 3 activities and personnel to advise and counsel students and support the
- 4 field-based teacher education experiences of students.
- 5 Sec. 426. (1) The teaching excellence fund appropriated in section 101 is
- 6 created to recognize outstanding teaching performance by faculty members of
- 7 state universities.
- 8 (2) An award of \$2,500.00 shall be made to faculty members selected by a
- 9 process administered by each university which provides for participation by
- 10 students and members of the faculty. The students and faculty members
- 11 participating in the selection process shall be representative of all segments
- 12 of the campus community, including academic discipline, academic level,
- 13 instructional level, race, and sex. Students shall comprise at least 1/3 of
- 14 the selection committee. All faculty members in the tenure track of a
- 15 university shall be eligible for selection for an award.
- 16 (3) The criteria to be used in the selection process are to be limited to
- 17 the following: superior classroom performance, innovative instructional
- 18 practice, high educational standards, and concern for students in and out of
- 19 the classroom.
- 20 (4) By May 1, 1991 each university receiving teaching excellence funds
- 21 shall report to the legislature and the department of management and budget the
- 22 following: the names of faculty members receiving teaching excellence fund
- 23 awards, the basis for each award, and a description of the selection process,
- 24 including the names, sex, and race of the students and faculty members
- 25 participating in the selection process; and also the names, sex, and race of
- 26 the recipients shall be provided in each annual report.

- 1 (5) Each institution shall receive a number of awards based on the number 2 of full-time faculty as follows:
- 3 (a) 2 awards each: Lake Superior state university, Saginaw valley state 4 university, university of Michigan at Flint, university of Michigan at 5 Dearborn, and Grand valley state university.
- 6 (b) 4 awards each: Michigan technological university, northern Michigan 7 university, and Oakland university.
- 8 (c) 6 awards each: Ferris state university and central Michigan 9 university.
- 10 (d) 8 awards each: eastern Michigan university and western Michigan 11 university.
- 12 (e) 12 awards: Wayne state university.
- 13 (f) 18 awards: university of Michigan at Ann Arbor.
- 14 (g) 20 awards: Michigan state university.
- 15 The funds awarded under this section shall not supplant current
- 16 institutional expenditures devoted to the selection and monetary recognition of
- 17 outstanding teaching performance by faculty members.
- 18 Sec. 427. Each state university shall submit an annual report to the
- 19 department of management and budget and to the chairpersons of the house and
- 20 senate higher education appropriations subcommittees in a manner prescribed by
- 21 the department of management and budget describing each energy conservation
- 22 project financed wholly or in part by oil overcharge revenues appropriated in
- 23 fiscal year 1987 and fiscal year 1988. The report shall include a description
- 24 of each energy conservation project and the actual expenditures and energy
- 25 savings estimates. The information contained in the report shall be utilized
- 26 to meet the annual reporting requirements to the United States district court

- 1 and the United States secretary of energy regarding state use of oil overcharge 2 refunds.
- 3 Sec. 428. From the funds appropriated in section 101 for Michigan state
- 4 university, the legislature encourages that \$150,000.00 be expended for the
- 5 collegiate employment research institute and that those funds expended be
- 6 accounted for independently.
- 7 Sec. 429. It is the intent of the legislature that funds from the Martin
- 8 Luther King, Jr.-Cesar Chavez-Rosa Parks program shall not be used for any
- 9 purpose other than the purposes designated in this act.
- 10 Sec. 430. It is the intent of the legislature to fund the consortium on
- 11 race relations from the funds appropriated under this act. The consortium is
- 12 to be comprised of the race relations institute at Wayne state university, and
- 13 the institute for the study of race and ethnic relations at western Michigan
- 14 university. The consortium is to be governed by an advisory council consisting
- 15 of 2 members from Wayne state university, 2 members from western Michigan
- 16 university, and chairs of the house and senate higher education appropriations
- 17 subcommittees. The consortium shall conduct research; provide outreach
- 18 programs; promote racial and ethnic harmony; and encourage participation and
- 19 commitments from other higher education institutions and communities.
- 20 Sec. 431. The legislature recommends that the ratio of out-of-state
- 21 students at any public institution not exceed a ratio of 30% of undergraduate
- 22 student enrollment and 38% of graduate student enrollment.
