

HOUSE BILL No. 5598

March 13, 1990, Introduced by Reps. Niederstadt and Hart and referred to the Committee on Towns and Counties.

A bill to amend section 206 of Act No. 213 of the Public Acts of 1982, entitled
"Michigan revised uniform limited partnership act,"
being section 449.1206 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 206 of Act No. 213 of the Public Acts of
2 1982, being section 449.1206 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 206. (a) A document required or permitted to be filed
5 under this act shall be filed by delivering the document to the
6 administrator together with the fees and accompanying documents
7 required by law. A person who executes a certificate as an
8 attorney in fact, agent, or fiduciary need not exhibit evidence
9 of his or her authority as a prerequisite to filing. If the
10 document substantially conforms to the requirements of this act,

1 the administrator shall endorse upon it the word "filed" with his
2 or her official title and the dates of receipt and of filing,
3 ~~thereof,~~ and shall file and index the document or a ~~microfilm~~
4 ~~or other reproduced copy thereof~~ REPRODUCTION OF THE DOCUMENT
5 PURSUANT TO THE RECORDS MEDIA ACT in his or her office. If so
6 requested at the time of the delivery of the document to his or
7 her office, the administrator shall include the hour of filing in
8 his or her endorsement ~~thereon~~ ON THE DOCUMENT. The adminis-
9 trator shall prepare and return a true copy of the document, or
10 at his or her discretion the original, ~~thereof,~~ to the person
11 who submitted it for filing showing the filing date. ~~thereof.~~
12 The records and files of the administrator relating to limited
13 partnerships shall be open to reasonable inspection by the
14 public. The records or files may, at the discretion of the
15 administrator, be maintained either in their original form or in
16 ~~microfilm or other reproduced~~ THE form OF REPRODUCTIONS PURSU-
17 ANT TO THE RECORDS MEDIA ACT. The administrator may make
18 ~~copies~~ REPRODUCTIONS of ~~all~~ documents filed under this act,
19 or any predecessor act, ~~by microfilm or other process~~ PURSUANT
20 TO THE RECORDS MEDIA ACT and may destroy the originals of the
21 documents so ~~copied~~ REPRODUCED.

22 (b) The document is effective at the time it is endorsed
23 unless a subsequent effective time, ~~is set forth in the document~~
24 ~~which shall~~ not ~~be~~ later than 90 days after the date of
25 delivery, IS SET FORTH IN THE DOCUMENT.

1 (c) The administrator may, at his or her discretion, require
2 that a document required or permitted to be filed under this act
3 be on a form prescribed by the administrator.

4 Section 2. This amendatory act shall not take effect unless
5 House Bill No. 5013 of the 85th Legislature is enacted into law.
