

HOUSE BILL No. 5609

March 14, 1990, Introduced by Reps. Pitoniak, Weeks, Gire, Martin, Giese, Law, Kulchitsky, Johnson, Joe Young, Jr., Wallace and Sparks and referred to the Committee on Transportation.

A bill to amend section 232 of Act No. 300 of the Public Acts of 1949, entitled as amended
"Michigan vehicle code,"
being section 257.232 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 232 of Act No. 300 of the Public Acts of
2 1949, being section 257.232 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 232. (1) The secretary of state shall furnish to
5 chiefs of police in cities of an estimated population of 10,000
6 or more and to sheriffs of counties — a list of the motor vehi-
7 cle registrations and ~~such~~ NECESSARY RELATED information.
8 ~~relating thereto as may be necessary. The~~ EXCEPT AS PROVIDED
9 IN SUBSECTION (3), THE secretary of state ~~is hereby authorized~~
10 ~~to~~ MAY sell ~~any~~ AT A REASONABLE PRICE surplus lists ~~he may~~

5 (2) ~~The~~ EXCEPT AS PROVIDED IN SUBSECTION (3), THE secre-
6 tary of state ~~is hereby authorized to~~ MAY sell AT A REASONABLE
7 PRICE, or contract for the sale of, any motor vehicle registra-
8 tion lists in addition to those distributed at no cost under
9 ~~this section~~ SUBSECTION (1) and to sell AT A REASONABLE PRICE
10 or furnish any other information from the records of the depart-
11 ment pertaining to the sale, ownership, and operation of motor
12 vehicles. The ~~secretary of state shall fix a reasonable price~~
13 ~~or charge for the sale of such lists or other information and~~
14 ~~the proceeds therefrom~~ FROM SALES DESCRIBED IN THIS SECTION
15 shall be ~~added~~ CREDITED to the state highway fund. ~~provided~~
16 ~~for herein.~~

17 (3) MOTOR VEHICLE REGISTRATION LISTS AND OTHER INFORMATION
18 SOLD OR FURNISHED UNDER THIS SECTION SHALL NOT CONTAIN THE RESI-
19 DENTIAL ADDRESS OF AN OWNER OF A MOTOR VEHICLE UNLESS THE OWNER
20 CONSENTS, IN WRITING, TO THE RELEASE OF HIS OR HER ADDRESS. THIS
21 SUBSECTION DOES NOT APPLY TO MOTOR VEHICLE REGISTRATION LISTS AND
22 OTHER INFORMATION FURNISHED TO CHIEFS OF POLICE AND SHERIFFS OF
23 COUNTIES.
