- 1 other cruel and inhuman manner, or -shall carry or cause WHO
- 2 CARRIES OR CAUSES to be carried a live animal in or upon a vehi-
- 3 cle or otherwise without providing a suitable rack, car, crate,
- 4 or cage, in which the animal may stand or lie down during trans-
- 5 portation, and while awaiting slaughter, or who -shall abandon-
- 6 ABANDONS an animal, in any place, without making provisions for
- 7 the animal's adequate care, or who -shall willfully or negli-
- 8 gently permit and allow PERMITS AND ALLOWS an aged, diseased,
