

HOUSE BILL No. 5772

May 16, 1990, Introduced by Rep. Niederstadt and referred to the Committee on Towns and Counties.

A bill to amend section 6a of Act No. 1 of the Public Acts of the Extra Session of 1936, entitled as amended "Michigan employment security act," being section 421.6a of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 6a of Act No. 1 of the Public Acts of
2 the Extra Session of 1936, being section 421.6a of the Michigan
3 Compiled Laws, is amended to read as follows:

4 Sec. 6a. ~~The commission may by~~ BY resolution adopted by a
5 majority of its members, THE COMMISSION MAY destroy or dispose of
6 ~~any files, records or other papers at any time after they have~~
7 A DOCUMENT THAT HAS been retained in the commission files FOR NOT
8 LESS THAN 2 years ~~, and which in its opinion are no longer of~~
9 ~~any~~ AND THAT IN THE COMMISSION'S OPINION IS OF NO value to the
10 commission, and may authorize the director to make or cause to be

1 made ~~such summaries or compilations, photographs, duplications~~
2 ~~or reproductions as he may deem~~ A REPRODUCTION IN A MEDIUM PUR-
3 SUANT TO THE RECORDS MEDIA ACT, OR A SUMMARY OR COMPILATION, THAT
4 HE OR SHE CONSIDERS advisable to preserve the information con-
5 tained ~~therein. When originals shall have been destroyed at~~
6 ~~times and in the manner above specified, the summaries, compila-~~
7 ~~tions, photographs, duplications or reproductions referred to~~
8 ~~above shall be admissible in evidence the same as originals,~~
9 ~~when~~ IN THE DOCUMENT. IF AN ORIGINAL DOCUMENT IS DESTROYED OR
10 DISPOSED OF PURSUANT TO THIS SECTION, A REPRODUCTION OF THE DOCU-
11 MENT IN A MEDIUM PURSUANT TO THE RECORDS MEDIA ACT, OR A SUMMARY
12 OR COMPILATION OF THE DOCUMENT, IF certified by the director to
13 be A true ~~and~~ accurate ~~and~~ official ~~copies~~ REPRODUCTION,
14 COMPILATION, OR SUMMARY of the original, OR A REPRODUCTION MADE
15 FROM SUCH A MEDIUM, SO CERTIFIED, THAT IS A DURABLE MEDIUM FOR
16 REPRODUCING THE ORIGINAL, IS ADMISSIBLE IN EVIDENCE THE SAME AS
17 THE ORIGINAL in any proceeding before the commission, referee, OR
18 appeal board and in all courts. ~~if the original would have~~
19 ~~been admissible therein.~~ Information contained on printouts pre-
20 pared by automatic data processing equipment ~~shall~~ IS also ~~be~~
21 admissible in evidence, if the original ~~files, records or other~~
22 ~~papers~~ DOCUMENTS from which such information was obtained would
23 have been admissible. ~~therein.~~

24 Section 2. This amendatory act shall not take effect unless
