- 8 PROVIDER FOR COVERED BASIC HEALTH SERVICES RENDERED UNLESS A
- 9 REVIEW OF THE REQUEST FOR PAYMENT, CONTINUED CARE, OR OTHER

- 1 BENEFITS HAS BEEN CONDUCTED BY A STATE LICENSED AND PRACTICING
- 2 MEMBER OF THE SAME PROFESSION AS THE PROFESSIONAL OR PROVIDER
