

# HOUSE BILL No. 5864

June 7, 1990, Introduced by Reps. Martin, Stabenow, Profit, Bartnik, Fitzgerald, Honigman, London, Gire, Nye, Crandall, Hoffman and Jaye and referred to the Committee on Judiciary.

A bill to amend section 4701 of Act No. 236 of the Public Acts of 1961, entitled as amended  
"Revised judicature act of 1961,"  
as added by Act No. 104 of the Public Acts of 1988, being section 600.4701 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Section 1. Section 4701 of Act No. 236 of the Public Acts  
2 of 1961, as added by Act No. 104 of the Public Acts of 1988,  
3 being section 600.4701 of the Michigan Compiled Laws, is amended  
4 to read as follows:

5       Sec. 4701. As used in this chapter:

6       (a) "Crime" means 1 of the following offenses in connection  
7 with which the forfeiture of property is sought:

1 (i) A violation of section 4, 5, or 7 of the medicaid false  
2 claim act, Act No. 72 of the Public Acts of 1977, being sections  
3 400.604, 400.605, and 400.607 of the Michigan Compiled Laws.

4 (ii) A violation of section 2 or 3 of the Michigan antitrust  
5 reform act, Act No. 274 of the Public Acts of 1984, being sec-  
6 tions 445.772 and 445.773 of the Michigan Compiled Laws.

7 (iii) A violation of section 409 of the uniform securities  
8 act, Act No. 265 of the Public Acts of 1964, being section  
9 451.809 of the Michigan Compiled Laws.

10 (iv) A violation of section 5 or 7 of Act No. 33 of the  
11 Public Acts of 1978, being sections 722.675 and 722.677 of the  
12 Michigan Compiled Laws.

13 (v) A violation of section 75, 94, 95, 96, 100, 104, 105,  
14 106, 110, 112, 117, 118, 119, 120, 121, 124, 140, 145A, 145B,  
15 145c, 157q, 157r, 174, 175, 176, 180, 181, 182, 213, 214, 218,  
16 224, 248, 249, 250, 251, 252, 253, 254, 255, 271, 272, 273, 274,  
17 300, 356, 357, 357a, 359, 360, 529, 530, 531, or 535 of the  
18 Michigan penal code, Act No. 328 of the Public Acts of 1931,  
19 being sections 750.75, 750.94, 750.95, 750.96, 750.100, 750.104,  
20 750.105, 750.106, 750.110, 750.112, 750.117, 750.118, 750.119,  
21 750.120, 750.121, 750.124, 750.140, 750.145A, 750.145B, 750.145c,

1 (vi) A violation of section 219a of Act No. 328 of the  
2 Public Acts of 1931, being section 750.219a of the Michigan  
3 Compiled Laws, if the total value of the telephone service  
4 obtained is over \$100.00.

5 (vii) A VIOLATION OF SECTION 5 OR 6 OF ACT NO. 343 OF THE  
6 PUBLIC ACTS OF 1984, BEING SECTIONS 752.365 AND 752.366 OF THE  
7 MICHIGAN COMPILED LAWS.

8 (viii) ~~(vii)~~ Conspiracy to commit an offense listed in  
9 subparagraphs (i) to ~~(vi)~~ (vii).

10 (b) "Instrumentality of a crime" means any property, other  
11 than real property, the use of which contributes directly and  
12 materially to the commission of a crime.

13 (c) "Person" means an individual, corporation, partnership,  
14 or other business entity, or an unincorporated or voluntary  
15 association.

16 (d) "Proceeds of a crime" means any property obtained  
17 through the commission of a crime, including any appreciation in  
18 the value of the property.

19 (e) "Security interest" means any interest in real or per-  
20 sonal property that secures payment or performance of an  
21 obligation.

22 (f) "Substituted proceeds of a crime" means any property  
23 obtained or any gain realized by the sale or exchange of proceeds  
24 of a crime.
