- 5 Sec. 512. (1) "Paraplegic or quadriplegic" means an indi-

- 7 this act, who is a paraplegic or quadriplegic at the end of the
- 8 tax year.

- 1 (2) "Property taxes" means general ad valorem taxes due and

- 19 tional exemptions allowed for age or blindness.
- 20 (4) "Renter" means a person renting or leasing a homestead.
