## **HOUSE BILL No. 5978**

September 11, 1990, Introduced by Rep. Bryant and referred to the Committee on Transportation.

A bill to amend section 612 of Act No. 300 of the Public Acts of 1949, entitled as amended

"Michigan vehicle code,"

as amended by Act No. 33 of the Public Acts of 1990, being section 257.612 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 612 of Act No. 300 of the Public Acts of
- 2 1949, as amended by Act No. 33 of the Public Acts of 1990, being
- 3 section 257.612 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 612. (1) —When— IF traffic is controlled by traffic
- 6 control signals, not less than 1 signal shall be located over the
- 7 traveled portion of the roadway so as to give drivers a clear
- 8 indication of the right of way assignment from their normal
- 9 positions approaching the intersection. The vehicle signals

- 1 shall exhibit different colored lights successively, 1 at a time,
- 2 or with arrows. Red arrow and yellow arrow indications have the
- 3 same meaning as the corresponding circular indications, except
- 4 that they apply only to drivers of vehicles intending to make the
- 5 movement indicated by the arrow. The following colors shall be
- 6 used and the terms and lights shall indicate and shall apply to
- 7 drivers of vehicles as follows:
- 8 (a) If the signal exhibits a green indication, vehicular
- 9 traffic facing the signal, -except when UNLESS prohibited under
- 10 section 664, may proceed straight through or turn right or left
- 11 unless a sign at that place prohibits either turn. Vehicular
- 12 traffic, including vehicles turning right or left, shall yield
- 13 the right of way to other vehicles and to pedestrians lawfully
- 14 within the intersection or an adjacent crosswalk at the time
- 15 WHEN the signal is exhibited.
- (b) If the signal exhibits a steady yellow indication,
- 17 vehicular traffic facing the signal shall stop before entering
- 18 the nearest crosswalk at the intersection or at a limit line
- 19 -when- IF marked, but if the stop cannot be made in safety, a
- 20 vehicle may be driven cautiously through the intersection.
- (c) If the signal exhibits a steady red indication, the fol-
- 22 lowing -shall apply:
- 23 (i) Vehicular traffic facing a steady red signal alone shall
- 24 stop before entering the crosswalk on the near side of the inter-
- 25 section or at a limit line -when- IF marked or, if there is no
- 26 crosswalk or limit line, before entering the intersection, and

- 1 shall remain standing until a green indication is shown, except
- 2 as provided in subparagraph (ii).
- 3 (ii) Vehicular traffic facing a steady red signal, after
- 4 stopping before entering the crosswalk on the near side of the
- 5 intersection or at a limit line when marked or, if there is no
- 6 crosswalk or limit line, before entering the intersection, may
- 7 make a right turn from a 1-way or 2-way street into a 2-way
- 8 street or into a 1-way street carrying traffic in the direction
- 9 of the right turn, -; or a left turn from a 1-way -or 2 way-
- 10 street into a 1-way roadway carrying traffic in the direction of
- 11 the left turn, unless prohibited by sign, signal, marking, light,
- 12 or other traffic control device. The vehicular traffic shall
- 13 yield the right of way to pedestrians lawfully within an adjacent
- 14 crosswalk and to other traffic lawfully using the intersection.
- (d) If the signal exhibits a steady green arrow indication,
- 16 vehicular traffic facing the green arrow signal, shown alone or
- 17 in combination with another indication, may cautiously enter the
- 18 intersection only to make the movement indicated by the arrow --
- 19 or other movement permitted by other indications shown at the
- 20 same time. The vehicular traffic shall yield the right of way to
- 21 pedestrians lawfully within an adjacent crosswalk and to other
- 22 traffic lawfully using the intersection.
- (2) If a traffic control signal is erected and maintained at
- 24 a place other than an intersection, the provisions of this sec-
- 25 tion -shall be applicable except as to APPLY EXCEPT those provi-
- 26 sions -which- THAT by their nature cannot -have application.
- 27 Any APPLY. A stop required shall be made at a sign or marking

- 1 on the pavement indicating where the stop shall be made, but, in 2 the absence of a sign or marking, the stop shall be made at the
- 3 signal.
- 4 (3) A person who violates subsection (1) or (2) is responsi-
- 5 ble for a civil infraction.
- 6 (4) A driver of a vehicle who approaches a person using a
- 7 wheelchair or a device to aid the person to walk at a crosswalk
- 8 or any other pedestrian crossing shall take such precautions as
- 9 may be necessary to avoid accident or injury to the person using
- 10 the wheelchair or device. A person who violates this subsection
- 11 is quilty of a misdemeanor.
- 12 (5) A sign prohibiting a turn on a red signal as provided in
- 13 subsection (1)(c)(ii) shall be located above or adjacent to the
- 14 traffic control signal or as close as possible to the point where
- 15 the turn is made, or at both locations, so that 1 or more of the
- 16 signs are visible to a driver intending to turn at the point
- 17 where the turn is made. An additional sign may be used at the
- 18 far side of the intersection in the direct line of vision of the
- 19 turning driver.
- 20 Section 2. This amendatory act shall take effect April 1,
- 21 1991.
