## HOUSE BILL No. 6039

September 13, 1990, Introduced by Reps. Trim and DeMars and referred to the Committee on Tourism, Fisheries and Wildlife.

A bill to amend the title and section 6 of Act No. 285 of the Public Acts of 1931, entitled as amended

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 3 Sec. 6. The commission shall make and adopt a master plan
- 4 for the physical development of the municipality, including any
- 5 areas outside of its boundaries which, in the commission's judg-

- 8 matter shall show the commission's recommendations for the devel-

- 1 LIMITS OF THIS STATE INCLUDING THOSE WATERS OF THE GREAT LAKES
- 2 THAT ARE UNDER THE JURISDICTION OF THIS STATE. As the work of
- 3 making the whole master plan progresses, the commission from time
- 4 to time may adopt and publish parts -thereof OF THE PLAN, any
- 5 such part to cover 1 or more major sections or divisions of the
- 6 municipality or 1 or more of the aforesaid or other functional
- 7 matters to be included in the plan. The commission from time to
- 8 time may amend, extend, or add to the plan.
