A bill to amend Act No. 106 of the Public Acts of 1963, entitled

"An act to define, control and prohibit the littering of public and private property and waters; to prescribe penalties for violation of this act; and to repeal certain acts and parts of acts,"

- 1 (A) A BALLOON RELEASED BY A PERSON ON BEHALF OF A

- 12 (2) A PERSON RESPONSIBLE FOR THE RELEASE OF A BALLOON PURSU-
- 13 ANT TO SUBSECTION (1)(D) SHALL, UPON REQUEST, MAKE AVAILABLE TO
- 14 THE DEPARTMENT OF NATURAL RESOURCES OR ANY LAW ENFORCEMENT OFFI-
- 15 CER EVIDENCE OF THE BALLOON'S BIODEGRADABILITY OR
- 16 PHOTODEGRADABILITY.
- 17 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A CIVIL
- 18 INFRACTION PUNISHABLE BY A FINE OF NOT LESS THAN \$250.00.
- 19 (4) A PERSON MAY PETITION THE CIRCUIT COURT TO ENJOIN THE
- 20 RELEASE OF A BALLOON IF THAT PERSON IS A RESIDENT OF THE COUNTY
- 21 IN WHICH THE BALLOON IS TO BE RELEASED.
- 22 (5) FOR PURPOSES OF THIS SECTION, "BALLOON" MEANS A NON-
- 23 POROUS BAG OF TOUGH, LIGHT MATERIAL FILLED WITH HEATED AIR OR A
- 24 GAS LIGHTER THAN AIR SO AS TO RISE AND FLOAT IN THE ATMOSPHERE.
