- 7 PAYMENTS SHALL BE DISTRIBUTED IN ACCORDANCE WITH THIS SECTION.
- 8 (2) THE STATE DEPARTMENT SHALL PROMULGATE RULES TO PROVIDE
- 9 FOR A DISTRIBUTION SYSTEM IN WHICH RECIPIENTS PICK UP ASSISTANCE
