- 7 TARY SPECIALIZATION CERTIFICATION IN CERTAIN AREAS OF LAW

- 21 (3) THE STATE BAR OF MICHIGAN MAY ESTABLISH A MICHIGAN BOARD
- 22 OF LEGAL SPECIALIZATION IN THE MANNER PRESCRIBED BY RULE FOR THE
- 23 PURPOSE OF ADMINISTERING THE LEGAL SPECIALIZATION PROGRAM. THE
- 24 STATE BAR OF MICHIGAN MAY PROVIDE BY RULE FOR THE ESTABLISHING OF
