

HOUSE BILL No. 6158

November 8, 1990, Introduced by Reps. Johnson, Berman, Jondahl, Stabenow, Hunter, Gilmer, Banks, Krause, Martin and Perry Bullard and referred to the Committee on Public Health.

A bill to amend section 2301 of Act No. 368 of the Public Acts of 1978, entitled as amended
"Public health code,"
being section 333.2301 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 2301 of Act No. 368 of the Public Acts
2 of 1978, being section 333.2301 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 2301. (1) The department, utilizing broad participa-
5 tion of, and providing ample opportunity for the submission of
6 recommendations by, the individuals and organizations described
7 in section 2302, annually shall identify the priority health
8 problems of this state utilizing state health plans and an
9 assessment procedure based on data and statistics consistent with
10 or provided for in sections 2616 and ~~2617i~~ 2617.

1 Identification of priority health problems related to mental
2 health shall be made with the consultation and advice of the
3 department of mental health. From these priorities, the depart-
4 ment annually shall prepare a proposed list of basic preventive,
5 personal, and environmental health services to be made available
6 and accessible to all residents in need of the services in this
7 state without regard for place of residence, marital status, sex,
8 age, race, or inability to pay.

9 (2) The list of proposed basic health services shall be
10 based upon the capabilities of the health related arts and
11 sciences and upon criteria related to health needs, resources,
12 and performance and shall take into account the services provided
13 by private practitioners and private providers of health
14 services. THE LIST OF PROPOSED BASIC HEALTH SERVICES SHALL
15 INCLUDE, BUT IS NOT LIMITED TO, FAMILY PLANNING SERVICES. To the
16 extent that the proposed list of basic health services includes
17 mental health services for which responsibility has been vested
18 in state or local mental health agencies by THE MENTAL HEALTH
19 CODE, Act No. 258 of the Public Acts of 1974, as amended, being
20 sections 330.1001 to 330.2106 of the Michigan Compiled Laws, or
21 rules promulgated ~~pursuant to~~ UNDER that act, the inclusion of
22 those services in the proposed list ~~shall be~~ IS subject to the
23 approval of the department of mental health.

24 (3) AS USED IN THIS SECTION, "FAMILY PLANNING SERVICES"
25 MEANS THE PROCESS OF ESTABLISHING OBJECTIVES FOR THE NUMBER AND
26 SPACING OF ONE'S CHILDREN AND SELECTING THE MEANS BY WHICH THOSE
27 OBJECTIVES MAY BE ACHIEVED. THE MEANS MAY INCLUDE A BROAD RANGE

1 OF MEDICALLY ACCEPTABLE AND EFFECTIVE METHODS AND SERVICES TO
2 LIMIT OR ENHANCE FERTILITY, INCLUDING, BUT NOT LIMITED TO,
3 CONTRACEPTIVE DRUGS AND DEVICES AND INFERTILITY MANAGEMENT.
4 FAMILY PLANNING SERVICES INCLUDES, BUT IS NOT LIMITED TO, PRECON-
5 CEPTIVE COUNSELING, EDUCATION, GENERAL REPRODUCTIVE HEALTH CARE,
6 AND PRESCRIBING OR DISPENSING CONTRACEPTIVE DRUGS OR DEVICES.
7 FAMILY PLANNING SERVICES DOES NOT INCLUDE PRENATAL AND PREGNANCY
8 RELATED HEALTH CARE OR ABORTION SERVICES.
