"Sand dune protection and management act,"

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 2 of Act No. 222 of the Public Acts of
- 2 1976, as amended by Act No. 146 of the Public Acts of 1989, being
- 3 section 281.652 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 2. As used in this act:
- 6 (a) "Barrier dune" means the first landward sand dune forma-
- 7 tion along the shoreline of a Great Lake or a sand dune formation
- 8 designated by the department.

- (b) "Cell-unit" means a subunit of the total sand dune
- 2 mining project as determined in size and location by the
- 3 operator, but which shall not exceed 10 acres in size for new
- 4 operations or the expansion of existing operations, and which
- 5 shall not exceed 30 acres in size for existing operations.
- 6 (c) "Commission" means the commission of <del>natural resources</del>
- 7 CONSERVATION AND RECREATION.
- 8 (d) "Department" means the department of natural resources.
- 9 (e) "Director" means the director of the department or his
- 10 or her authorized representative.
- (f) "Great Lakes" means any of the Great Lakes which has a
- 12 shoreline within the state.
- (g) "Operator" means an owner or lessee of mineral rights or
- 14 any other person engaged in or preparing to engage in mining
- 15 operations with respect to mineral rights within a sand dune
- 16 area.
- (h) "Person" means an individual, partnership, firm, corpo-
- 18 ration, association, local unit of government, or other political
- 19 subdivision of the state, or a state or state agency.
- 20 (i) "Sand dune area" means that area designated by the
- 21 department which includes those geomorphic features composed pri-
- 22 marily of sand, whether windblown or of other origin and which
- 23 lies within 2 miles of the ordinary high-water mark on a Great
- 24 Lake as defined in section 2 of the Great Lakes submerged lands
- 25 act, Act No. 247 of the Public Acts of 1955, as amended, being
- 26 section 322.702 of the Michigan Compiled Laws, and includes
- 27 critical dune areas.

- (j) "Sand dune mining" means the removal of sand from sand
- 2 dune areas for commercial, or industrial purposes, or both.
- 3 Section 2. This amendatory act shall not take effect unless
- 4 all of the following bills of the 85th Legislature are enacted
- 5 into law:
