THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 16a of Act No. 183 of the Public Acts of
- 2 1943, being section 125.216a of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 16a. (1) As used in this section, "state licensed res-
- 5 idential facility" OR "RESIDENTIAL FACILITY" means a structure
- 6 constructed for residential purposes that is licensed by the
- 7 state pursuant to THE ADULT FOSTER CARE FACILITY LICENSING ACT,
- B Act No. 287 218 of the Public Acts of 1972 1979, as amended,
- 9 being sections -331.681 to 331.694 400.701 TO 400.737 of the
- O Michigan Compiled Laws, or Act No. 116 of the Public Acts of

- 1 1973, as amended, being sections 722.111 to 722.128 of the
- 2 Michigan Compiled Laws, -which THAT provides -resident services
- 3 for 6 or less persons under 24-hour supervision or care for 6 OR
- 4 FEWER persons in need of that supervision or care.
- 5 (2) In order to implement the policy of this state that
- 6 -persons A PERSON in need of community residential care shall
- 7 not be excluded by zoning from the benefits of normal residential
- 8 surroundings, a state licensed residential facility -providing
- 9 supervision or care, or both, to 6 or less persons shall be con-
- 10 sidered a MULTIPLE FAMILY residential use of property for the
- 11 purposes of zoning and a permitted use ONLY in -all- MULTIPLE
- 12 FAMILY residential zones, -including those zoned for single
- 13 family dwellings, and shall IS not be subject to a special
- 14 use or conditional use permit or procedure different from those
- 15 required for other dwellings of similar density in the same
- 16 zone.
- 17 (3) This section -shall DOES not apply to adult foster care
- 18 facilities licensed by a state agency for care and treatment of
- 19 -persons A PERSON released from or assigned to AN adult correc-
- 20 tional institutions INSTITUTION.
- 21 (4) At least 45 days before licensing a residential
- 22 facility, described in subsection (1), the state licensing
- 23 agency shall notify the county board of commissioners or its des-
- 24 ignated agency of the county where the proposed RESIDENTIAL
- 25 facility is to be located to review the number of existing or
- 26 proposed -similar state licensed residential facilities whose
- 27 property lines are within a 1,500 foot radius of the property

- 1 lines of the location of the applicant PROPOSED RESIDENTIAL
- 2 FACILITY. The county board of commissioners of a county or an
- 3 agency of the county to which the authority is delegated may,
- 4 when a proposed RESIDENTIAL facility is to be located within the
- 5 county, give appropriate notification of the proposal to license
- 6 the RESIDENTIAL facility to -those residents whose property
- 7 lines are within a 1,500 foot radius of the property lines of the

- O licensed residential facility exists within the 1,500 foot

- 3 tially contribute to an excessive concentration of state licensed
- 4 residential facilities within the county. This subsection
- 5 -shall DOES not apply to state licensed residential facilities
- 6 caring for 4 or -less FEWER minors.
- 7 (5) This section -shall DOES not apply to a state licensed
- 8 residential facility licensed before March 31, 1977, or to a res-
- 9 idential facility -which THAT was in the process of being devel-
- 10 oped and licensed before March 31, 1977, if approval had been
- 11 granted by the appropriate local governing body.
- Section 2. This amendatory act shall not take effect unless
- 3 all of the following bills of the 85th Legislature are enacted
