A bill to amend section 6 of Act No. 451 of the Public Acts of 1976, entitled as amended

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 17 OUS SCHOOL YEAR, THE NUMBER OF PUPILS, IDENTIFIED AT THE ELEMEN-
- 18 TARY, MIDDLE, AND SECONDARY SCHOOL LEVELS, WHO ARE ENROLLED IN
- 19 SCHOOL IN THE SCHOOL DISTRICT.
- 20 (2) NOT LATER THAN JULY 1, 1990, THE STATE BOARD SHALL PRE-
- 21 PARE AND MAKE AVAILABLE TO SCHOOL DISTRICTS SUGGESTIONS FOR ACCU-
- 22 MULATING THE INFORMATION LISTED IN SUBSECTION (1) AND A MODEL
- 23 EDUCATIONAL REPORT FOR SCHOOL DISTRICTS TO CONSIDER IN THE IMPLE-

- 25 SEC. 1277. (1) THE BOARD OF A SCHOOL DISTRICT, CONSIDERING

- 4 ADVISORY COMMITTEE TECHNICAL CONSULTANTS TO ADVISE ON THE VALIDI-

- 7 (7) THE REQUIREMENT OF TAKING A STATE-APPROVED BASIC AND
- 8 EMPLOYABILITY SKILLS TEST SHALL BE IN ADDITION TO ANY OTHER
- 9 REQUIREMENTS ESTABLISHED BY LAW OR BY THE BOARD OF A LOCAL SCHOOL
- 10 DISTRICT.
- 11 (8) BEGINNING MAY 1, 1991, A PUPIL SHALL BE GIVEN AN OPPOR-
- 12 TUNITY TO TAKE HIS OR HER LOCAL SCHOOL DISTRICT'S BASIC AND
- 13 EMPLOYABILITY SKILLS TEST IN THE 10TH GRADE AND SHALL BE REQUIRED
- 14 TO TAKE THE TEST BEFORE GRADUATION.
- 15 (9) A PUPIL WHO IS ASSESSED AS NOT COMPETENT IN A SUBJECT OR
- 16 SKILL AREA TESTED BY A BASIC AND EMPLOYABILITY SKILLS TEST MAY
- 17 REPEAT THE TEST AT LEAST ONCE DURING THE SCHOOL YEAR. IN ADDI-
- 18 TION, THE SCHOOL BOARD OF THE SCHOOL DISTRICT IN WHICH THE PUPIL
- 19 IS ENROLLED SHALL PROVIDE THAT THERE BE AT LEAST 1 MEETING
- 20 ATTENDED BY AT LEAST THE PUPIL, A PARENT, LEGAL GUARDIAN, OR
- 21 PERSON IN LOCO PARENTIS OF THE PUPIL, AND A MEMBER OF THE SCHOOL
- 22 DISTRICT'S STAFF WHO IS COMPETENT IN THE MEASUREMENT AND EVALU-
- 23 ATION OF PUPILS. THE PURPOSE OF EACH MEETING SHALL BE TO DETER-
- 24 MINE AN EDUCATIONAL PROGRAM FOR THE PUPIL WHICH IS DESIGNED TO

- 7 SCHOOL DIPLOMA, AN INDIVIDUAL MAY REPEAT THE BASIC AND EMPLOYABI-
- 8 LITY SKILLS TEST AT ANY TIME THE SCHOOL DISTRICT REGULARLY OFFERS
- 9 THE TEST AND UPON DEMONSTRATION OF COMPETENCE SHALL BE GIVEN A
- 10 REVISED TRANSCRIPT INDICATING COMPETENCY IN THE SUBJECT OR SKILL
- 11 AREA IN WHICH HE OR SHE WAS PREVIOUSLY ASSESSED AS NOT
- 12 COMPETENT.
- 13 (12) NOT LATER THAN JANUARY 1, 1993 AND EACH YEAR THEREAF-
- 14 TER, THE STATE BOARD SHALL SUBMIT IN WRITING A SUMMARY ANALYSIS
- 15 OF THE BASIC AND EMPLOYABILITY SKILLS TEST PROGRAM TO THE SENATE
- 16 AND HOUSE COMMITTEES THAT HAVE THE RESPONSIBILITY FOR EDUCATION
- 17 LEGISLATION.
- 18 (13) THE STATE BOARD MAY EXEMPT SPECIAL EDUCATION PUPILS
- 19 FROM THE REQUIREMENTS OF THIS SECTION.
