THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 503. (1) THE UNINSURED EMPLOYER'S SECURITY FUND IS

- 7 THE UNINSURED EMPLOYER'S SECURITY FUND. AFTER THE EFFECTIVE DATE

- 25 AN EMPLOYER FOR WHOM A RECEIVER IS APPOINTED BY A COURT.
