- 1 (2) A DEFENDANT IN A CRIMINAL ACTION FOR CRIMINAL SEXUAL
- 2 CONDUCT IN ANY DEGREE OR ASSAULT WITH INTENT TO COMMIT CRIMINAL
- 3 SEXUAL CONDUCT SHALL NOT COMMENCE A CIVIL ACTION AGAINST A VICTIM
- 4 OF THE CRIME FOR WHICH THE DEFENDANT IS CHARGED IF BOTH OF THE
