## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 34 of Act No. 8 of the Public Acts of

- 4 Sec. 34. (1) Public highways, public parks and places of
- 5 amusement. No alcoholic ALCOHOLIC liquor shall NOT be consumed

- 7 (2) EXCEPT AS PROVIDED IN SUBSECTIONS (3) AND (4), alcoholic
- 8 liquor -, except beer and/or wine shall MAY be POSSESSED OR

- 1 OR A PUBLICLY OWNED AREA licensed to sell for consumption on the 2 premises.
- 3 (3) THE GOVERNING BODY OF A LOCAL GOVERNMENTAL UNIT MAY PRO-

- 14 (B) "PUBLICLY OWNED AREA" MEANS AN AREA UNDER THE JURISDIC-
