- 5 SEC. 2701. AS USED IN THIS PART:
- 6 (A) "CHILD" MEANS A MINOR AS DEFINED IN SECTION 1105.
- 7 (B) "PANEL" MEANS THE CHILD MORTALITY REVIEW PANEL CREATED
- 8 IN SECTION 2703.

- 1 SEC. 2703. (1) THE CHILD MORTALITY REVIEW PANEL IS CREATED
- 2 IN THE DEPARTMENT TO CONDUCT MULTIDISCIPLINARY REVIEW OF CHILD
- 3 DEATHS. THE PANEL SHALL CONSIST OF ALL OF THE FOLLOWING
- 4 INDIVIDUALS:
- 5 (A) A REPRESENTATIVE OF THE DEPARTMENT.
- 6 (B) A REPRESENTATIVE FROM THE OFFICE WITHIN THE DEPARTMENT

- 14 (2) MEMBERS OF THE PANEL SHALL BE REIMBURSED FOR THEIR

- 16 SEC. 2705. (1) THE PANEL SHALL DO ALL OF THE FOLLOWING:

- 25 DEATHS. THE RECOMMENDATIONS SHALL ADDRESS GAPS OR PROBLEMS IN

- 8 (A) STAFF SUPPORT AND ASSISTANCE.
- 9 (B) USE OF THE DEPARTMENT'S NETWORK OF MEDICAL ADVISORY
- 10 BODIES FOR PROVISION OF MEDICAL EXPERTISE.
- 11 (C) USE OF THE DEPARTMENT'S RECORDS AND REPORTING CAPACITY
- 12 FOR MORTALITY SURVEILLANCE TO SUPPORT THE REVIEW PROCESS.
- 13 (D) PEDIATRIC MEDICINE CONSULTATION.
