HOUSE BILL No. 4820

May 15, 1989, Introduced by Reps. Johnson and Martin and referred to the Committee on Tourism, Fisheries and Wildlife.

A bill to amend the title and section 1 of Act No. 372 of the Public Acts of 1927, entitled as amended

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license; and to repeal all acts and parts of acts inconsistent with the provisions of this act,"

being section 28.421 of the Michigan Compiled Laws; and to add sections 3, 3a, 3b, 3c, 3d, 3e, 3f, 3g, 3h, 3i, 3j, 3k, and 3l.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title and section 1 of Act No. 372 of the

- 8 1931, BEING SECTION 750.222 OF THE MICHIGAN COMPILED LAWS.
- 9 (H) (c) "Seller" means any person, INCLUDING, BUT NOT
- 10 LIMITED TO, A DEALER, who sells, furnishes, loans, or gives a
- 11 pistol to another PERSON.
- 12 (I) "SEMIAUTOMATIC RIFLE" MEANS A RIFLE EMPLOYING GAS PRES-
- 13 SURE OR FORCE OF RECOIL TO MECHANICALLY EJECT AN EMPTY CARTRIDGE
- 14 FROM THE RIFLE AFTER A SHOT, AND TO LOAD THE NEXT CARTRIDGE FROM
- 15 THE MAGAZINE, BUT REQUIRING RENEWED PRESSURE ON THE TRIGGER FOR
- 16 EACH SUCCESSIVE SHOT.
- 17 (J) "SHORT-BARRELED PISTOL" MEANS ANY FIREARM, LOADED OR
- 18 UNLOADED, 30 INCHES OR LESS IN LENGTH, AND WITH A BARREL LENGTH
- 19 OF LESS THAN 5 INCHES.
- 20 SEC. 3. BEFORE PURCHASING A REGULATED RIFLE OR A
- 21 SHORT-BARRELED PISTOL FROM A DEALER, A PERSON SHALL CONSENT IN
- 22 WRITING ON A FORM PROVIDED BY THE DEPARTMENT, TO HAVE THE DEALER
- 23 OBTAIN CRIMINAL HISTORY RECORD INFORMATION FROM THE DEPARTMENT.
- 24 SEC. 3A. A FIREARMS DEALER SHALL NOT SELL OR TRANSFER A
- 25 REGULATED RIFLE OR A SHORT-BARRELED PISTOL TO A RESIDENT OF THIS
- 26 STATE UNTIL HE OR SHE HAS DONE ALL OF THE FOLLOWING:

- 1 (A) OBTAINED A WRITTEN CONSENT FORM FROM THAT RESIDENT
- 2 PERMITTING THE DEALER TO CONTACT THE DEPARTMENT TO OBTAIN THE

- 4 (B) PROVIDED THE DEPARTMENT WITH INFORMATION REGARDING THE

- 6 PERSON SEEKING TO PURCHASE THE REGULATED RIFLE OR SHORT-BARRELED
- 7 PISTOL.
- 8 (C) REQUESTED AND RECEIVED BY TELEPHONE THE CRIMINAL HISTORY
- 9 OF THE PERSON SEEKING TO PURCHASE THE REGULATED RIFLE OR
- 10 SHORT-BARRELED PISTOL.
- 11 SEC. 3B. (1) THE DEPARTMENT SHALL ESTABLISH AND MAINTAIN A
- 12 TOLL-FREE TELEPHONE NUMBER TO RESPOND TO CRIMINAL HISTORY INFOR-
- 13 MATION INQUIRIES BY DEALERS. THE NUMBER SHALL BE OPERATIONAL 7
- 14 DAYS A WEEK BETWEEN THE HOURS OF 8:00 A.M. AND 10:00 P.M., AND
- 15 THE DEPARTMENT SHALL RESPOND TO DEALER INQUIRIES DURING THOSE
- 16 HOURS. EXCEPT AS PROVIDED IN SUBSECTION (2), IF A DEALER
- 17 REQUESTS BY TELEPHONE THE CRIMINAL HISTORY OF A PERSON SEEKING TO
- 18 PURCHASE A REGULATED RIFLE OR A SHORT-BARRELED PISTOL, THE
- 19 DEPARTMENT SHALL PROVIDE THE CRIMINAL HISTORY OF THAT PERSON TO
- 20 THE DEALER AT THE TIME THE DEALER REQUESTS THAT INFORMATION BY
- 21 TELEPHONE, OR BY RETURN CALL WITHOUT DELAY.
- 22 (2) IF A CRIMINAL HISTORY INVESTIGATION INDICATES THAT A
- 23 PERSON SEEKING TO PURCHASE A REGULATED RIFLE OR A SHORT-BARRELED
- 24 PISTOL HAS A CRIMINAL RECORD, THE DEPARTMENT SHALL HAVE UNTIL THE
- 25 END OF THE DEALER'S NEXT BUSINESS DAY TO ADVISE THE DEALER
- 26 WHETHER ITS RECORDS INDICATE THAT THE PURCHASER IS PROHIBITED
- 27 FROM PURCHASING A REGULATED RIFLE OR SHORT-BARRELED PISTOL BY

- 1 STATE OR FEDERAL LAW. IF THE DEPARTMENT FAILS TO PROVIDE THE
- 2 INFORMATION REQUIRED UNDER THIS SUBSECTION TO A DEALER BY THE END-
- 3 OF THAT DEALER'S NEXT BUSINESS DAY, THE DEALER MAY IMMEDIATELY
- 4 COMPLETE THE SALE OR TRANSFER OF THE REGULATED RIFLE OR THE
- 5 SHORT-BARRELED PISTOL TO THAT PERSON. A SALE OR TRANSFER MADE
- 6 UNDER THIS SUBSECTION IS NOT A VIOLATION OF THIS ACT.
- 7 SEC. 3C. IN THE CASE OF ELECTRONIC FAILURE OR OTHER CIRCUM-
- 8 STANCES BEYOND THE CONTROL OF THE DEPARTMENT, THE DEPARTMENT
- 9 SHALL IMMEDIATELY NOTIFY THE DEALER OF ANY DELAY IN OBTAINING
- 10 INFORMATION FOR THE CRIMINAL HISTORY INVESTIGATION AND PROVIDE
- 11 THE DEALER WITH AN ESTIMATE OF THE LENGTH OF THAT DELAY. IF A
- 12 DEALER IS NOTIFIED OF A DELAY UNDER THIS SUBSECTION, THE DEPART-
- 13 MENT SHALL, AS SOON AS POSSIBLE, BUT NOT LATER THAN THE DEALER'S
- 14 NEXT BUSINESS DAY, INFORM THE DEALER OF WHETHER THE RECORDS OF
- 15 THE DEPARTMENT INDICATE THAT THE PURCHASER IS PROHIBITED FROM
- 16 PURCHASING A REGULATED RIFLE OR SHORT-BARRELED PISTOL BY STATE OR
- 17 FEDERAL LAW. A DEALER WHO REQUESTS A CRIMINAL HISTORY INVESTIGA-
- 18 TION BUT IS TOLD THAT A RESPONSE WILL NOT BE AVAILABLE BY THE END
- 19 OF THAT DEALER'S NEXT BUSINESS DAY MAY IMMEDIATELY COMPLETE THE
- 20 SALE OR TRANSFER OF THE REGULATED RIFLE OR SHORT-BARRELED PISTOL
- 21 TO THAT PURCHASER. A SALE OR TRANSFER MADE UNDER THIS SUBSECTION
- 22 IS NOT A VIOLATION OF THIS ACT.
- 23 SEC. 3D. THE DEPARTMENT OF STATE POLICE SHALL NOT RETAIN A
- 24 RECORD OF A CRIMINAL HISTORY INVESTIGATION REQUESTED BY A DEALER
- 25 IF THE PURCHASER OR TRANSFEREE IS NOT PROHIBITED FROM PURCHASING
- 26 A REGULATED RIFLE OR SHORT-BARRELED PISTOL BY STATE OR FEDERAL
- 27 LAW. A LOG OF A CRIMINAL HISTORY REQUEST MADE BY A DEALER IS NOT

- 1 A RECORD OF A CRIMINAL HISTORY INVESTIGATION UNDER THIS SECTION
- 2 AND MAY BE RETAINED BY THE DEPARTMENT FOR NOT LONGER THAN 1 YEAR
- 3 AFTER THE CRIMINAL HISTORY REQUEST IS MADE BY THAT DEALER.
- 4 SEC. 3E. A DEALER WHO REQUESTS A CRIMINAL HISTORY INVESTI-
- 5 GATION BY TELEPHONE UNDER THIS ACT SHALL FURNISH A COPY OF THE
- 6 WRITTEN CONSENT FORM SIGNED BY THE PERSON SEEKING TO PURCHASE THE
- 7 REGULATED RIFLE OR SHORT-BARRELED PISTOL TO THE DEPARTMENT BY
- 8 FIRST-CLASS MAIL, OR BY PERSONAL DELIVERY, WITHIN 24 HOURS AFTER
- 9 SALE OR TRANSFER IS MADE. UPON RECEIPT OF THE CONSENT FORM, THE
- 10 DEPARTMENT SHALL IMMEDIATELY SEARCH ALL CRIMINAL HISTORY RECORD
- 11 INFORMATION AVAILABLE TO THE DEPARTMENT TO DETERMINE WHETHER THE
- 12 PURCHASER IS PROHIBITED FROM PURCHASING A REGULATED RIFLE OR
- 13 SHORT-BARRELED RIFLE BY STATE OR FEDERAL LAW. IF THE SEARCH
- 14 REVEALS THAT THE PERSON IS PROHIBITED FROM PURCHASING A REGULATED
- 15 RIFLE OR SHORT-BARRELED PISTOL BY STATE OR FEDERAL LAW. THE
- 16 DEPARTMENT SHALL, WITHOUT DELAY, NOTIFY THE PROSECUTING ATTORNEY
- 17 OF THE COUNTY IN WHICH THE SALE OR TRANSFER WAS MADE, AND THE
- 18 DEALER, OF THE PROHIBITION.
- 19 SEC. 3F. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), A DEALER
- 20 SHALL NOT SELL OR TRANSFER A REGULATED RIFLE OR SHORT-BARRELED
- 21 PISTOL TO A PERSON WHO IS NOT A RESIDENT OF THIS STATE UNLESS
- 22 BOTH OF THE FOLLOWING CIRCUMSTANCES EXIST:
- 23 (A) THE DEALER HAS PROVIDED THE DEPARTMENT WITH A WRITTEN
- 24 CONSENT FORM SIGNED BY THE PERSON SEEKING TO PURCHASE THE REGU-
- 25 LATED RIFLE OR SHORT-BARRELED PISTOL BY FIRST-CLASS MAIL OR BY
- 26 PERSONAL DELIVERY WITHIN 24 HOURS AFTER THE FORM IS SIGNED BY
- 27 THAT PERSON.

- 1 (B) THE DEALER HAS RECEIVED INFORMATION FROM THE DEPARTMENT
- 2 THAT THE PERSON IS NOT PROHIBITED FROM PURCHASING A REGULATED
- 3 RIFLE OR SHORT-BARRELED PISTOL BY STATE OR FEDERAL LAW.
- 4 (2) A DEALER WHO HAS PROVIDED A COPY OF THE WRITTEN CONSENT
- 5 FORM TO THE DEPARTMENT AND WHO HAS NOT BEEN INFORMED BY THE
- 6 DEPARTMENT WITHIN 10 DAYS AFTER THE CONSENT FORM IS MAILED OR
- 7 DELIVERED WHETHER OR NOT THAT PERSON IS PROHIBITED FROM PURCHAS-
- 8 ING A REGULATED RIFLE OR A SHORT-BARRELED PISTOL BY STATE OR FED-
- 9 ERAL LAW MAY IMMEDIATELY COMPLETE THE SALE OR TRANSFER OF THE
- 10 REGULATED RIFLE OR THE SHORT-BARRELED PISTOL TO THAT PERSON.
- 11 SEC. 3G. (1) A PERSON WHO IS DENIED THE RIGHT TO PURCHASE A
- 12 REGULATED RIFLE OR A SHORT-BARRELED PISTOL UNDER THIS ACT MAY
- 13 OBTAIN A COPY OF HIS OR HER CRIMINAL HISTORY BY FILING A SIGNED
- 14 WRITTEN REQUEST FOR THAT INFORMATION WITH THE DEPARTMENT. THE
- 15 DEPARTMENT SHALL PROVIDE A COPY OF THAT PERSON'S CRIMINAL HISTORY
- 16 INFORMATION WITHIN 72 HOURS AFTER THE REQUEST FOR THAT INFORMA-
- 17 TION IS RECEIVED BY THE DEPARTMENT.
- 18 (2) A PERSON WHO IS DENIED THE RIGHT TO PURCHASE A REGULATED
- 19 RIFLE OR A SHORT-BARRELED PISTOL UNDER THIS ACT MAY FILE A CIVIL
- 20 ACTION IN A COURT OF PROPER JURISDICTION TO CORRECT CRIMINAL HIS-
- 21 TORY INFORMATION PROVIDED BY THE DEPARTMENT TO A DEALER. A CIVIL
- 22 ACTION UNDER THIS SUBSECTION SHALL BE FILED WITHIN 30 DAYS AFTER
- 23 THE PERSON'S REQUEST TO PURCHASE A REGULATED FIREARM OR
- 24 SHORT-BARRELED RIFLE IS DENIED.
- 25 SEC. 3H. A DEALER WHO WILLFULLY AND INTENTIONALLY REQUESTS,
- 26 OBTAINS, OR SEEKS TO OBTAIN CRIMINAL HISTORY INFORMATION UNDER
- 27 FALSE PRETENSES, OR WHO WILLFULLY AND INTENTIONALLY DISSEMINATES

- 1 OR SEEKS TO DISSEMINATE CRIMINAL HISTORY INFORMATION EXCEPT AS
- 2 AUTHORIZED UNDER THIS ACT, IS GUILTY OF A MISDEMEANOR.
- 3 SEC. 31. A LICENSED FIREARM DEALER SHALL COLLECT A FEE OF
- 4 \$2.00 FROM EACH RESIDENT, AND \$5.00 FROM EACH NONRESIDENT, WHO
- 5 PURCHASES A REGULATED FIREARM OR A SHORT-BARRELED RIFLE UNDER
- 6 THIS ACT. THE DEALER SHALL FORWARD ALL OF THE FEES COLLECTED
- 7 UNDER THIS SECTION TO THE DEPARTMENT OF TREASURY ON THE TWENTIETH
- 8 DAY OF EACH MONTH. THE DEPARTMENT OF TREASURY SHALL DEPOSIT ALL
- 9 OF THE FEES COLLECTED UNDER THIS SECTION IN THE GENERAL FUND.
- 10 SEC. 3J. A PERSON WHO WILLFULLY AND MATERIALLY MAKES A
- 11 FALSE STATEMENT ON A CONSENT FORM SIGNED TO PURCHASE A REGULATED
- 12 RIFLE OR SHORT-BARRELED PISTOL IS GUILTY OF A MISDEMEANOR.
- 13 SEC. 3K. THE OFFICE OF CRIMINAL JUSTICE SHALL PROMULGATE
- 14 RULES TO ENSURE THE IDENTITY OF PERSONS SEEKING CRIMINAL HISTORY
- 15 INFORMATION UNDER THIS ACT AND TO PROTECT THE CONFIDENTIALITY AND
- 16 SECURITY OF RECORDS AND DATA PROVIDED BY THE DEPARTMENT TO DEAL-
- 17 ERS UNDER THIS ACT.
- 18 SEC. 32. SECTIONS 3A THROUGH 3K DO NOT APPLY TO ANY OF THE
- 19 FOLLOWING:
- 20 (A) SALES OR TRANSFERS BETWEEN PERSONS WHO ARE LICENSED
- 21 UNDER FEDERAL LAW AS FIREARMS IMPORTERS, COLLECTORS, MANUFACTUR-
- 22 ERS, OR DEALERS.
- 23 (B) SALES OR TRANSFERS TO A LAW ENFORCEMENT OFFICER OF THIS
- 24 STATE, A LAW ENFORCEMENT OFFICER OF A LOCAL UNIT OF GOVERNMENT OF
- 25 THIS STATE, OR A LAW ENFORCEMENT OFFICER OF THE UNITED STATES.
- 26 (C) ANTIQUE SHORT-BARRELED HANDGUNS OR PISTOLS.
