THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 9407 of Act No. 174 of the Public Acts
- 2 of 1962, as amended by Act No. 130 of the Public Acts of 1988,
- 3 being section 440.9407 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 9407. (1) If the person filing a financing statement,
- 6 termination statement, statement of assignment, or statement of
- 7 release furnishes the filing officer a copy of the statement, the
- 8 filing officer shall upon request note upon the copy the file

- 1 number and date and hour of the filing of the original and
 2 deliver or send the copy to the person.
- 3 (2) Upon request of any person, the filing officer shall
- 4 issue a certificate showing whether there is on file, on the date
- 5 and hour stated on the certificate, any presently effective
- 6 financing statement naming a particular debtor and any statement
- 7 of assignment and, if there is, giving the date and hour of
- 8 filing of each statement and the names and addresses of each
- 9 secured party in the statement. The uniform fee for a certifi-
- 10 cate is \$3.00 PLUS \$1.00 FOR EACH SECURED PARTY LISTED IN THE
- 11 CERTIFICATE if the request for the certificate is in the standard
- 12 form prescribed by the secretary of state and, for certificates
- 13 which concern financing statements filed beginning September 1,
- 14 1988, includes the social security number of the debtor or the
- 15 debtor's federal employer tax identification number. If the
- 16 request does not comply with these requirements, the fee is \$6.00
- 17 PLUS \$1.00 FOR EACH SECURED PARTY LISTED IN THE CERTIFICATE.
- 18 Upon request, the filing officer shall furnish a copy of a filed
- 19 financing statement or statement of assignment for a uniform fee
- 20 of \$1.00 \$2.00 per page. The secretary of state shall charge
- 21 an additional fee of \$25.00 if a person requests expediting of
- 22 the regular search process. The secretary of state shall promul-
- 23 gate rules under the administrative procedures act of 1969, Act
- 24 No. 306 of the Public Acts of 1969, being sections 24.201 to
- 25 24.328 of the Michigan Compiled Laws, to define what constitutes
- 26 expediting of the regular search process.
