- 6 CLASS BEFORE THE END OF THE ACADEMIC TERM OR, IF A MAKEUP CLASS
- 7 IS NOT CONDUCTED, THE COMMUNITY COLLEGE SHALL REIMBURSE TO EACH
- 8 STUDENT ENROLLED IN THE CLASS AN AMOUNT EQUAL TO THE AMOUNT OF
- 9 TUITION THE STUDENT HAS PAID FOR THE CLASS, DETERMINED BY

- 1 DIVIDING THE LENGTH OF THE CANCELED CLASS PERIOD BY THE TOTAL
- 2 NUMBER OF CONTACT HOURS FOR THE COURSE AND MULTIPLYING THAT OUO-
- 3 TIENT BY THE TOTAL AMOUNT OF TUITION THE STUDENT HAS PAID FOR THE

- 5 (2) AS USED IN THIS SECTION:
- 6 (A) "ACADEMIC TERM" MEANS THE TERM, SEMESTER, OUARTER, OR
- 7 TRIMESTER IN WHICH THE CANCELED CLASS OCCURS.
- 8 (B) "CANCELED CLASS" MEANS A CLASS THAT DOES NOT MEET DURING
- 9 ITS SCHEDULED TIME PERIOD THROUGH NO FAULT OF THE STUDENTS
- 10 ENROLLED IN THE CLASS, WHETHER OR NOT THE STUDENTS WERE NOTIFIED
- 11 IN ADVANCE THAT THE CLASS WOULD NOT MEET.
- 12 (C) "CLASS" MEANS A SINGLE REGULARLY SCHEDULED MEETING OF A
- 13 COURSE OFFERED BY THE COMMUNITY COLLEGE.
