

HOUSE BILL No. 5345

December 11, 1989, Introduced by Reps. Berman, Gubow, Emerson, DeMars, Bartnik, Sofio, Dolan, Brown and Stabenow and referred to the Committee on Appropriations.

A bill to amend section 108 of Act No. 280 of the Public Acts of 1939, entitled as amended

"The social welfare act,"

being section 400.108 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 108 of Act No. 280 of the Public Acts of
2 1939, being section 400.108 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 108. (1) A medically indigent person as defined under
5 ~~subdivision (1)~~ SUBSECTION (1)(A) of section 106 ~~is enti-~~
6 tled to all the services enumerated in ~~subsections (a), (b),~~
7 ~~(c), (d), (e) and (f)~~ SUBSECTION (1) of section 109. A medi-
8 cally indigent person as defined under ~~subdivision (2)~~
9 SUBSECTION (1)(B) of section 106 is entitled to medical services
10 enumerated in ~~subsections~~ SUBSECTION (1) (a), (c), and (e) of

1 section 109. He OR SHE shall also be entitled to the services
2 enumerated in ~~subsections~~ SUBSECTION (1) (b), (d), and (f) of
3 section 109 to the extent of appropriations made available by the
4 legislature for the fiscal year. Medical services shall be
5 rendered upon certification by the attending licensed physician
6 and dental services shall be rendered upon certification of the
7 attending licensed dentist that a service is required for the
8 treatment of an individual. The services of a medical institu-
9 tion shall be rendered only after referral by a licensed physi-
10 cian or dentist and certification by him OR HER that the services
11 of the medical institution are required for the medical or dental
12 treatment of the individual, except that referral is not neces-
13 sary in case of an emergency. ~~Periodic recertification that~~
14 ~~medical treatment which extends over a period of time is required~~
15 ~~in accordance with regulations of the state department shall be a~~
16 ~~condition of continuing eligibility to receive medical~~
17 ~~assistance.~~ IF AN INDIVIDUAL SEEKS MEDICAL ASSISTANCE OVER AN
18 EXTENDED PERIOD OF TIME, THE ATTENDING LICENSED PHYSICIAN OR DEN-
19 TIST SHALL PROVIDE PERIODIC RECERTIFICATION IN ACCORDANCE WITH
20 RULES OF THE STATE DEPARTMENT. To comply with federal statutes
21 governing medicaid, the state department shall provide such early
22 and periodic screening, diagnostic and treatment services to eli-
23 gible children as it ~~deems~~ CONSIDERS necessary.

24 (2) A MEDICALLY INDIGENT PERSON AS DEFINED IN SECTION 106 IS
25 ENTITLED TO ALL OF THE FOLLOWING, IF ORDERED BY THE PERSON'S
26 ATTENDING PHYSICIAN:

1 (A) IF THE PERSON IS AT LEAST 35 YEARS OF AGE BUT LESS THAN
2 40 YEARS OF AGE, 1 BREAST CANCER SCREENING MAMMOGRAPHY.

3 (B) IF THE PERSON IS 40 YEARS OF AGE OR OLDER, 1 BREAST
4 CANCER SCREENING MAMMOGRAPHY EVERY 12 MONTHS.

5 (C) BREAST CANCER DIAGNOSTIC SERVICES.

6 (D) BREAST CANCER OUTPATIENT TREATMENT SERVICES.

7 (E) BREAST CANCER REHABILITATIVE SERVICES.

8 (3) AS USED IN SUBSECTION (2), "BREAST CANCER SCREENING
9 MAMMOGRAPHY", "BREAST CANCER DIAGNOSTIC SERVICES", "BREAST CANCER
10 OUTPATIENT TREATMENT SERVICES", AND "BREAST CANCER REHABILITATIVE
11 SERVICES" MEAN THOSE TERMS AS DEFINED IN SECTION 3406D OF THE
12 INSURANCE CODE OF 1956, ACT NO. 218 OF THE PUBLIC ACTS OF 1956,
13 BEING SECTION 500.3406D OF THE MICHIGAN COMPILED LAWS.
