- 3 (C) REQUEST THAT ANY PROSECUTOR WITHIN THE STATE PROSECUTE A
- 4 VIOLATOR OF ANY LAW OR ORDINANCE THAT PROTECTS PERSONS FROM
- 5 DOGS.
- 6 (4) THE DIRECTOR OF THE DEPARTMENT OF AGRICULTURE SHALL
- 7 APPOINT A DEPUTY DIRECTOR OF THE DOG LAW ENFORCEMENT BUREAU TO
- 8 ADMINISTER AND DIRECT SUPERVISION OF ENFORCEMENT OF ALL LAWS AND
- 9 ORDINANCES PROTECTING PERSONS FROM DOGS.
- 10 (5) AS USED IN THIS SUBSECTION, "DOG" MEANS A DOMESTIC
- 11 MAMMAL OF THE SPECIES CANIS FAMILIARIS, OR ANY MAMMAL OF THE SPE-
- 12 CIES CANIS FAMILIARIS CROSSBRED WITH A MAMMAL OF THE SPECIES
- 13 CANIS LUPUS, COMMONLY KNOWN AS WOLF.
