## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1272b of Act No. 451 of the Public Acts

- 3 is amended and section 1272e is added to read as follows:

- 1 THAT ARE COMPATIBLE WITH THOSE FEDERAL NUTRITIONAL STANDARDS

- 9 OTHER FOOD AND BEVERAGES SOLD OR MADE AVAILABLE TO PUPILS ON
