## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411H. (1) A PERSON SHALL NOT KNOWINGLY DISTRIBUTE A
- 2 PAGING DEVICE TO A MINOR OR PROVIDE ACCESS TO A PAGING SERVICE TO
- 3 A MINOR IF THE PERSON KNOWS OR HAS REASON TO KNOW THE MINOR WILL
- 4 USE THE PAGING DEVICE OR PAGING SERVICE TO VIOLATE A LAW OF THIS

- 18 SEC. 4111. (1) A PERSON WHO SUBSCRIBES TO A PAGING SERVICE
- 19 SHALL NOT KNOWINGLY TRANSFER THE SUBSCRIPTION TO THAT SERVICE TO
- 20 A MINOR UNLESS THE PERSON PREPARES AN AFFIDAVIT THAT CONTAINS ALL
- 21 OF THE FOLLOWING:
- 22 (A) A STATEMENT OF THE PERSON'S FULL NAME AND ADDRESS.
- 23 (B) A STATEMENT OF THE MINOR'S FULL NAME AND ADDRESS.
- 24 (C) A STATEMENT OF THE MINOR'S AGE AND A STATEMENT THAT THE
- 25 SUBSCRIPTION IS BEING TRANSFERRED TO THAT MINOR.

- 1 (2) A PERSON WHO TRANSFERS A SUBSCRIPTION TO A PAGING
- 2 SERVICE UNDER SUBSECTION (1) SHALL RETAIN A COPY OF THE AFFIDAVIT
- 3 OF TRANSFER FOR A PERIOD OF 1 YEAR.
- 4 (3) A PERSON WHO TRANSFERS A SUBSCRIPTION TO A PAGING SERV-
- 5 ICE IN VIOLATION OF SUBSECTION (1), OR WHO KNOWINGLY PREPARES A
- 6 FALSE AFFIDAVIT OF THAT TRANSFER IS GUILTY OF A FELONY, PUNISH-
- 7 ABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS, OR A FINE OF NOT
- 8 MORE THAN \$2,000.00, OR BOTH.
- 9 (4) A PERSON WHO VIOLATES SUBSECTION (2) IS GUILTY OF A MIS-
- 10 DEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS,
- 11 OR A FINE OF NOT MORE THAN \$100.00, OR BOTH.
- 12 (5) AS USED IN THIS SECTION:
- 13 (A) "MINOR" MEANS AN INDIVIDUAL LESS THAN 18 YEARS OF AGE.
- 14 (B) "PAGING DEVICE" MEANS A PORTABLE 1-WAY COMMUNICATION
- 15 DEVICE DESIGNED TO PROVIDE AN INDIVIDUAL WITH NOTIFICATION OF, OR
- 16 INFORMATION ABOUT, MESSAGES.
- 17 (C) "PAGING SERVICE" MEANS A SERVICE DESIGNED TO PROVIDE
- 18 INDIVIDUALS WITH NOTIFICATION OF, OR INFORMATION ABOUT, MESSAGES
- 19 THROUGH THE USE OF PAGING DEVICES.
- 20 SEC. 411J. (1) A PERSON WHO CARRIES OR HAS IN HIS OR HER
- 21 POSSESSION A PAGING DEVICE AT THE TIME HE OR SHE COMMITS OR
- 22 ATTEMPTS TO COMMIT A FELONY VIOLATION OF SECTION 7401, 7402, OR
- 23 7403 OF THE PUBLIC HEALTH CODE, ACT NO. 368 OF THE PUBLIC ACTS OF
- 24 1978, BEING SECTIONS 333.7401, 333.7402, AND 333.7403 OF THE
- 25 MICHIGAN COMPILED LAWS, IS GUILTY OF A FELONY AND SHALL BE
- 26 IMPRISONED FOR 2 YEARS.

- 1 (2) THE TERM OF IMPRISONMENT PRESCRIBED BY THIS SECTION
- 2 SHALL BE IN ADDITION TO THE SENTENCE IMPOSED FOR THE CONVICTION
- 3 OF THE FELONY OR THE ATTEMPT TO COMMIT THE FELONY, AND SHALL BE
- 4 SERVED CONSECUTIVELY WITH AND PRECEDING ANY TERM OF IMPRISONMENT
- 5 IMPOSED FOR THE CONVICTION OF THE FELONY OR ATTEMPT TO COMMIT THE
- 6 FELONY.
- 7 (3) THE TERM OF IMPRISONMENT IMPOSED UNDER THIS SECTION
- 8 SHALL NOT BE SUSPENDED. THE PERSON SUBJECT TO THE SENTENCE MAN-
- 9 DATED BY THIS SECTION SHALL NOT BE ELIGIBLE FOR PAROLE OR PROBA-
- 10 TION DURING THE MANDATORY TERM IMPOSED PURSUANT TO SUBSECTION
- 11 (1).
- 12 (4) AS USED IN THIS SECTION, "PAGING DEVICE" MEANS A
- 13 PORTABLE 1-WAY COMMUNICATION DEVICE DESIGNED TO PROVIDE AN INDI-
- 14 VIDUAL WITH NOTIFICATION OF, OR INFORMATION ABOUT, MESSAGES.
