- 4 SEC. 803N. (1) A PERSON WHO WAS A MEMBER OF THE ARMED SERV-

- 6 803J, 803K, OR 803 MAY APPLY TO THE SECRETARY OF STATE FOR A
- 7 SPECIAL REGISTRATION PLATE, WHICH SHALL DISPLAY AN APPROPRIATE
- 8 VIGNETTE FOR EACH WAR IN WHICH THE PERSON WAS A MEMBER OF THE

- 1 ARMED SERVICES PRECEDING THE REGISTRATION NUMBERS AND SHALL HAVE
- 2 THE WORD "VETERAN" INSCRIBED BENEATH THE REGISTRATION NUMBERS.
- 3 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 4 A FORM PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE ACCOM-
- 5 PANIED BY ANY PROOF OF THE APPLICANT HAVING BEEN A VETERAN IN THE
- 6 WARS FOR WHICH THE PERSON HAS APPLIED THAT THE SECRETARY OF STATE

- 1 RENEWAL OF THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY
- 2 A \$5.00 SERVICE FEE. THE APPLICANT SHALL NOT BE REQUIRED TO FUR-
- 3 NISH THE PROOF PROVIDED IN SUBSECTION (2).
