THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 206 of the Public Acts of 1893, as

- 3 Laws, is amended by adding section 9d to read as follows:
- 4 SEC. 9D. (1) DAILY RENTAL PROPERTY THAT HAS A TRUE CASH
- 5 VALUE OF \$5,000.00 OR LESS IS EXEMPT FROM TAXATION UNDER THIS
- 6 ACT.
- 7 (2) DAILY RENTAL PROPERTY THAT HAS A TRUE CASH VALUE GREATER
- 8 THAN \$5,000.00 AND THAT IS COMMONLY FOUND IN OR USED TO MAINTAIN
- 9 A HOMESTEAD IS EXEMPT FROM TAXATION UNDER THIS ACT.

- 1 (3) A PORTION OF THE TRUE CASH VALUE OF DAILY RENTAL
- 2 PROPERTY THAT IS NOT EXEMPT UNDER SUBSECTION (1) OR (2) IS EXEMPT

- 9 TANGIBLE PERSONAL PROPERTY THAT IS UNDER A RENTAL AGREEMENT OR
- 10 THAT IS PRINCIPALLY INTENDED FOR RENT RATHER THAN SALE, THE POS-
- 11 SESSION OF WHICH PROPERTY IS TRANSFERRED FOR CONSIDERATION FOR AN
- 12 HOURLY, DAILY, WEEKLY, OR MONTHLY PERIOD. DAILY RENTAL PROPERTY
- 13 DOES NOT INCLUDE EITHER OF THE FOLLOWING:
- 14 (A) TANGIBLE PERSONAL PROPERTY THAT IS RENTED TO THE SAME
- 15 PERSON FOR A CONTINUOUS PERIOD OF MORE THAN 30 DAYS OR TO THE
- 16 SAME PERSON WITHIN 30 DAYS OF A PREVIOUS 30-DAY RENTAL.
- 17 (B) A MOTOR VEHICLE REQUIRED TO BE LICENSED UNDER THE
- 18 MICHIGAN VEHICLE CODE, ACT NO. 300 OF THE PUBLIC ACTS OF 1949,
- 19 BEING SECTIONS 257.1 TO 257.923 OF THE MICHIGAN COMPILED LAWS.
