- 3 Compiled Laws, is amended by adding section 2954 to read as
- 4 follows:
- 5 SEC. 2954. (1) AS USED IN THIS SECTION:
- 6 (A) "DEALER" MEANS THAT TERM AS DEFINED IN SECTION 11 OF THE
- 7 MICHIGAN VEHICLE CODE, ACT NO. 300 OF THE PUBLIC ACTS OF 1949,
- 8 BEING SECTION 257.11 OF THE MICHIGAN COMPILED LAWS.

- 1 (B) "USED OR SECONDHAND VEHICLE" MEANS THAT TERM AS DEFINED
- 2 IN SECTION 78 OF ACT NO. 300 OF THE PUBLIC ACTS OF 1949, BEING
- 3 SECTION 257.78 OF THE MICHIGAN COMPILED LAWS.
- 4 (2) A BUYER OF A USED OR SECONDHAND VEHICLE MAY BRING AN
- 5 ACTION SEEKING RESCISSION OR DAMAGES IN A COURT OF COMPETENT
- 6 JURISDICTION. IN AN ACTION UNDER THIS SECTION, THE PLAINTIFF
- 7 SHALL HAVE THE BURDEN OF PROVING ALL OF THE FOLLOWING BY CLEAR
- 8 AND CONVINCING EVIDENCE IN RELATION TO THE SALE:
- 9 (A) THE SELLER KNOWINGLY MADE A REPRESENTATION PERTAINING TO
- 10 THE VEHICLE THAT WAS BOTH MATERIAL AND FALSE.
- 11 (B) THE REPRESENTATION DESCRIBED IN SUBDIVISION (A) WAS MADE
- 12 WITH THE INTENT TO DECEIVE THE BUYER.
- 13 (C) THE BUYER ACTED IN RELIANCE UPON THE REPRESENTATION
- 14 DESCRIBED IN SUBDIVISION (A).
- 15 (D) THE BUYER SUFFERED A LOSS AS A CONSEQUENCE OF RELYING
- 16 UPON THE REPRESENTATION DESCRIBED IN SUBDIVISION (A).
- 17 (3) THIS SECTION SHALL APPLY TO ALL PERSONS INCLUDING, BUT
- 18 NOT LIMITED TO, A DEALER.
