THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 4 ELECTION FOR SCHOOL BOARD MEMBERS SIGN AND FILE WITH THE BOARD
- 5 BEFORE JANUARY 1, 1990 A PETITION REQUESTING THE ELECTION.
