- 4 SEC. 73A. (1) NOTWITHSTANDING ANY OTHER SECTION OF THIS
- 5 ACT, A PERSON WHO WILLFULLY AND MALICIOUSLY DAMAGES OR DESTROYS A
- 6 BUILDING OR OTHER REAL PROPERTY BY MEANS OF AN EXPLOSIVE OR
- 7 INCENDIARY DEVICE OR BY FIRE, AND THEREBY CAUSES THE DEATH OF A
- 8 PERSON, IS GUILTY OF A FELONY AND SHALL BE PUNISHED BY
- 9 IMPRISONMENT FOR LIFE.
